SCOPE OF WORK & IMPORTANT CONDITIONS

1. Complete Overhauling of EOT Crane of Capacity 30/10T capacity.
2. Complete Overhauling of DT Gantry Crane of Capacity 10T capacity.
3. Inspection of bus bar, power supply system of all equipment, checking servicing and resetting of all limit switches, panels to ensure proper and smooth electrical operation of crane Inspection of all gear box of crane Main Hoist, Long Travel & Cross Travel.
4. Replacement of Oil of all Gear Box. Oil will be provided by CSPGCL.
5. Replacement of Break Drum for Main Hoist .
6. Replacement of Hydraulic Thruster Break for Main Hoist.
7. Replacement of wear out Break Shoe.
8. Checking of all limit switches.
9. Complete Cleaning's & control checking of panel box.
10. Inspection of all wheels and replacement of its bearing..
11. Greasing of all bearings & grease points
12. Span checking of Rails.
13. Greasing of all motors.
14. Cardium compound (will be provided by CSPGCL) shall be applied to wire rope after cleaning.
15. Setting of all breaks.
16. Material supplied (EHT and Break shoe) will be as per standard specification and requirements and same should be replaced during work. Material must reached and should be available in site with the start of OH work therefore proper coordination for the same must be ensure to avoid any delay on work completion period.
17. All other necessary standard maintenance work which are not mentioned in documents but necessary for smooth and safe operation of Crane is under bidder scope.
18. After Complete Overhauling of crane complete trial will be done in the presence of Engineer In Charge.

19. Complete Inspection, Load testing and witness of 30/10T cranes at Gangrel HEP and valid certification.
20. All necessary arrangement for load testing and valid certification shall be done by bidder.
21. Work Completion Period :- Within 30 days from date of issue of order. As work to be completed on urgent basis therefore no request extension in contract period will be accepted. Therefore bidder must supply the material and execute the order within stipulated work completion period strictly.
22. **PENALTY:-** Please refer General Terms & Conditions of Purchase, Clause :12 and General Condition of work contract : Clause :12 or relevant clause in tender documents. No request for exemption in penalty shall be entertained.
