

GARE PELMA COAL BLOCK, MARWA* in separate envelope and appended over the sealed tender form envelope will be accepted latest by 4:00PM on due date of opening. *The tenders will be opened at 4:15PM on same day in the office of the S.E. (Civil)* in front of presented contractors or authorized representative of the participating contractors.
