A. Qualifying Requirements: -

The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfill the following Qualifying requirements: -

- (a) The bidder shall be Co-operative Societies having land oustees of land acquired for ash dyke and linked facilities of concerned Power Plant as member.

OR

- (b) (i) The firm having similar experience of one year during last five (05) Financial years ending 31.03.2021.
(ii) The average annual turnover of the firm in the preceding (03) three Financial years ending 31.03.2020 shall not be less than the start price per annum.

B. Documents required for providing eligibility of Qualifying Requirements: -

(a) For Co-operative Society :-


- (i) Registration of Co-operative society and members of Co-operative society.
(ii) Copy of verification report from concerned E.E.(Civil) confirming the members of Co-operative societies are land oustees or legally authorized family members of land oustees of concerned ash dyke of linked facilities.
(iii) If the Co-operative society has participated in previous works of collection of cenosphere in CSPGCL, then copy of satisfactory performance report certified by CSPGCL shall be submitted.
(iv) Co-operative society should not be debarred/blacklisted by the Govt./PSU/ local bodies/Power Generating Companies as on the date of auction. A declaration in this regard shall be furnished by the Co-operative society as per format given in Annexure-I.
(v) The Co-operative society should provide detailed information on any litigation or arbitration arising out of contracts completed or under execution by it over the last five years. A consistent history of awards involving litigation against the Co-operative society may result in rejection of Bid. A declaration in this regards shall be furnished by the Co-operative society as per format given in Annexure-II.
(vi) All the documents/statements/attachments/ information submitted by a Co-operative society in a proof of the qualifying requirements must be authentic/genuine/ correct. In case, any of the said documents/statements/attachments/information is found to be false/fake/ forged/misleading, the Co-operative society will be disqualified and action will be taken against the Co-operative society as per relevant provisions of the tender. A declaration in this regards shall be furnished by the Co-operative society as per format given in Annexure-III.

(b) For Other Bidders:-

- (i) In order to prove eligibility of S.No. (b) (i) of Qualifying Requirements, firms will have to submit a copy of certificate issued from coal based thermal power plant certifying experience of at least (01) one year in harvesting of Cenosphere from ash pond during last five years. Copy of PO issued from coal based thermal power plant shall also be enclosed.
(ii) In order to prove eligibility of S.No (b) (ii) of Qualifying Requirements. bidder will have to submit audited balance sheet and profit loss statement certified by Chartered Accountant for the year 2017-18, 2018-19 & 2019-20.
(iii) If the firm has participated in previous works of collection of cenosphere in CSPGCL, then copy of satisfactory performance report certified by CSPGCL shall be submitted.
(iv) Bidder should not be debarred/blacklisted by the Govt./PSU/ local bodies/Power Generating Companies as on the date of auction. A declaration in this regard shall be furnished by the bidder as per format given in Annexure-I.

- (v) The Bidder should provide detailed information on any litigation or arbitration arising out of contracts completed or under execution by it over the last five years. A consistent history of awards involving litigation against the bidder may result in rejection of Bid. A declaration in this regards shall be furnished by the bidder as per format given in Annexure-II.
- (vi) All the documents/statements/attachments/ information submitted by a bidder in a proof of the qualifying requirements must be authentic/genuine/ correct. In case, any of the said documents/statements/attachments/information is found to be false/fake/ forged/misleading, the bidder will be disqualified and action will be taken against the bidder as per relevant provisions of the tender. A declaration in this regards shall be furnished by the bidder as per format given in Annexure-III.

Note: All the bid related and prequalification documents shall reach the O/o CE (Civil) AU&PC, CSPGCL, Raipur on or before due date (upto 15:00 Hrs) of submission of PQR details documents as per Auction Notice in hard copy in a sealed envelope bearing the details of bidder and auction. Any delay in submission of documents shall not be entertained. All the document shall be duly signed by the bidders.
