

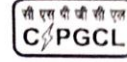



**3. Earnest Money deposit (EMD) Payment: (Offline)**

- a) EMD of stipulated value is to be submitted physically (Offline) for each tender separately, in prescribed form within the scheduled period.
- b) The EMD Envelope- II must be super scribed which should be clearly superscribed as "EMD" for tender <name/ number of tender, due date >
- c) EMD envelop should reach in the office of E.D (S&P:Gen) within the schedule date. CSPGCL will not be responsible in any way for late receipt of EMD due to any postal delay or delay of any form in transit.

**4. Technical Bid & Price Bid submission: (Online)**

- a) This is a E-tender case and bidders shall submit bid (Techno-commercial Bid & Price Bid) in ONLINE ONLY. The bidder have to upload the scanned copy of tender fee DD, GST registration certificate and EMD DD along with the tender document. The bidder may submit hard copy of techno-commercial bid only, in physical form, along with tender fees and EMD demand draft. Bids sent through any other means/ media may be liable to be rejected. The decision of CSPGCL shall be final and binding.
- b) Confirmation of Acceptance of scope of supply/work, Complete tender document i.e. General terms & Condition, Questionnaire Part and Schedule etc., along with deviation statement are to be attached in the link AUC FLOOR MANAGER → Attach docs→ Techno Commercial Bid.
- c) In case of any deviation in tech specification with respect to tender enquiry, same to be clearly specified as per deviation statement & are to be attached in the link AUC FLOOR MANAGER → Attach docs→ Techno Commercial Bid.
- d) Price justification document towards the quoted price ( in form of copy of P.O placed by any govt agency , PSU etc may be uploaded / attached in the link AUC FLOOR MANAGER → Attach docs→ Techno Commercial Bid.
- e) All the bid related documents are to be uploaded with bidders digital signatures in the tender document folder under created bid option.
- f) All attachment should be either on the Letter Pad of Company OR Company name should be mentioned on Header or Footer level.

**5. Tender Fee & EMD Document Submission- Offline:**

- a) Tender Fee & EMD is to be submitted in Physical Form / Offline within the scheduled period. First Envelope containing Tender Fee and GST registration certificate must be super scribed as "Envelop-I-Tender Fee" for tender <name/ number of tender, due date > & Second Envelope containing Earnest Money Deposit must be super scribed as "Envelop-II-Earnest Money Deposit" for tender <name/ number of tender, due date >.
- b) Above two Sealed envelopes (I&II) are to be kept in one envelop and be sealed properly. This sealed envelop must be super scribed as "Tender Fee & EMD for tender no". and addressed to The Executive Director (S&P: Gen), CSPGCL, 5<sup>th</sup> Floor, Vidhut Sewa Bhawan, Dangania, Raipur (CG) 492013. Please ensure that the envelope should reach in this office before scheduled closing date and time of submission of bid.
- c) Techno-commercial Bid / Price Bid of the Bidders who have not submitted requisite amount of Tender Fee and EMD shall not be considered.
- d) CSPGCL will not be responsible in any way for late receipt of these document (Tender fee & EMD) due to any postal delay or delay in any form in transit.
