I. TENDER FEE & EMD DEPOSIT:

- Online payment transaction charges will be displayed to the bidder as soon as bidder clicks on the "Payment" option and also in respective bank page after redirecting to Bank portal.
- Bidder can pay Tender Fee before the Submission deadline of RFx/Tender in e-bidding portal. Once the submission deadline is over, system will not allow to pay Tender Fee.
