NOTES:-**I. TENDER FEE & EMD DEPOSIT:**

1. Process for Online Payment of Tender Fee:

- Online payment transaction charges will be displayed to the bidder as soon as bidder clicks on the "Payment" option and also in respective bank page after redirecting to Bank portal.
