- (4) Process for online payment of Tender Fee:

The bidder shall deposit the Tender Fee amount as mentioned in the NIT & cover page of this tender specification. Process for Online Payment of Tender Fee:

- a. Bidder can participate in Tender only after the successful payment of Tender fee.
- b. Bidder has to pay Tender Fee online through CSPCL e-Bidding portal.
- c. For payment of Tender Fee, bidder can pay by through the following payment modes of the Bill Desk (Payment Gateway Provider):

- (6) Technical Bid (online) & EMD (online) for the above tender shall be opened on Bid Opening Date (BOD). Date of Price Bid opening (online) shall be intimated later on to all qualified bidder in due time.
- (7) Any Corrigendum / amendments, if required, shall be displayed on above websites only.
