NOTES:-**1. TENDER FEE & EMD DEPOSIT:**

I. Process for Online Payment of Tender Fee:

- Bidder can participate in Tender only after the successful payment of Tender fee.
- Bidder has to pay Tender Fee online through CSPCL e-Bidding portal.

 - If Waived bidders have not attached waiving certificate or the attached certificate duration is over/validity period expired. In such cases purchaser has right to reject the Bid.
- Tender without valid Earnest Money shall be summarily rejected
- Technical Bid (online) & EMD (online) for the above tender shall be opened on Bid Opening Date (BOD). Date of Price Bid opening (online) shall be intimated later on to all qualified bidder in due time.
