O. 2x500MW, ABVTPS CSPGCL Marwa Tendubhata in separate envelope and appended over the sealed tender form envelope will be accepted latest by 4.00 P.M. on due date of opening. The tenders will be opened at 4.15 P.M. on same day in the office of the S E (Civil) Circle I in front of presented contractors or authorized representatives of the participating contractors.
