I. TENDER FEE & EMD DEPOSIT:

I. Process for Online Payment of Tender Fee:

- Bidder can participate in Tender only after the successful payment of Tender fee.
- Bidder has to pay Tender Fee online through CSPCL e-Bidding portal.
- For Payment of Tender Fee, bidder can pay by through the following payment modes of the Bill Desk (Payment Gateway Provider):

All the above transaction charges will be borne by the bidders.

There may be some more Payment Gateway providers in future which will be added after approval of the management & completion of documentation formalities.

- Online payment transaction charges will be displayed to the bidder as soon as bidder clicks on the "Payment" option and also in respective bank page after redirecting to Bank portal.
- Bidder can pay Tender Fee before the Submission deadline of RFX/Tender in e-bidding portal. Once the submission deadline is over, system will not allow to pay Tender Fee.
- Bidder can download the payment receipt of Tender Fee immediately after its successful payment.
- The payment of Tender Fee is non-refundable as per prevailing practice.



- m. Bidder can download the payment receipt of EMD immediately after its successful payment.
- n. Bidders bid will be considered only if Tender Fees is paid and EMD is received by CS Power Companies expect for the waived bidders.
- o. Waived bidders can attach their waiving certificate in COLLABORATION folder before submitting the bid. Waiving certificate can be attached at any stage of Filling Response on e-bidding portal but it has to be done before submission deadline of RFX.
