### Scope of Work

- 1. The Car (Cat-III) shall be deployed to the **Superintending Engineer (Operation)**, at 2x500 MW, ABVTPS, CSPGCL, Marwa and shall be utilized as per his job requirement and functional liabilities. The vehicle will be deployed for average monthly run up to **1000 KM**.
- 2. The vehicle should be in good condition and should be new or not more than five year old and having total run not exceeding 100000 Km. The vehicle should meet general requirement of Regional Transport authorities and should comply all the Govt. rules, regulations and notifications for deploying the vehicle as in force or subsequently modified from time to time. The contractor shall obtain all permissions for deploying the vehicle on hire basis from competent authority after paying due taxes.
- 3. Total duration of this contract shall be period of One (12 month) years.
- 4. The contractor will be fully responsible for accident, injury, damage caused by their vehicle to their own employee, employee of CSPGCL, or any other third party and compensate for any loss or damages. The vehicle should be insured comprehensively.
- 5. The contractor should have ownership or the legal Authority of the vehicle to be deployed on hire against his contract.
- 6. The contractor will have to keep all the documents like registration book, taxi permit, insurance policy, fitness certificate, driving license etc. up to date all the time with vehicle and submit a copy of same to the Officer-In-Charge before deploying the vehicle. The contractor shall be responsible for all the obligations of Govt. Rules & Regulations for deploying vehicle under Taxi category. If the contractor fails to comply these requirements, the SD will not be released.
- 7. The Government Taxes like toll taxes, commercial tax etc.(except GST), if any become payable during the contract period, the same will have to be paid by the contractor.
- 8. The price variation clause shall be applicable to the contract as per the variation in prices in Diesel/Petrol. The base rate for variation shall be taken from date of deployment of vehicle as per the CSPGCL standard terms & conditions.
- 9. Only Diesel/Petrol vehicle is allowed to engage against this contract. Gas kit is not allowed.
- 10. All consumable like diesel, engine oil, grease etc. repair of vehicle, wages of driver and govt. taxes will be arranged by the contractor at their own cost.
- 11. The contractor shall have to pay the driver wages, EPF, ESIC and Bonus as per the notification of the Labour Commissioner GoCG. Contractor shall have to submit the relevant document for driver's wages duly verified by Sr. Welfare Officer,2x500MW ABVTPS along with the bill.
- 12. The vehicle will have to be kept always in ready condition with driver, fuel (minimum 30 Liters) so that vehicle can be sent anywhere in Chhattisgarh whenever required. TA/DA etc of the driver has to be arranged by the contractor.
- 13. If the vehicle is required to be kept out of service for repair or servicing etc. the contractor has to arrange another equivalent vehicle in replacement. Similarly leave substitute of driver has to be arranged by the contractor.
- 14. In case of vehicle outage/unavailability, penalty @ 1050/- per day shall be deducted. In case of unavailability of driver penalty @ 350/- per day shall be deducted. However the maximum amount of above penalty will be limited to 10% of total order value.
- 15. Payment will be made through R.A. Bill. The calculation for extra/less run charges will be made on quarterly average run basis, for which payment will be made every quarterly.
- 16. In case of emergency, the vehicle will be driven by CSPGCL officers having valid driving license at your risk. The contractor will have to provide step nee and toolkit with the vehicle ready all the time.
- 17. The vehicle shall be engaged on contract only after thorough inspection and satisfactory performance of the vehicle. The agreement on non judicial paper worth Rs. 50/- shall be executed after physical verification and successful trial of the vehicle provided by contractor.
- 18. The vehicle will be required for use round the clock and shall be parked in the company's premises.
- 19. The Log Book of the vehicle shall be filled in by the driver daily and the signature of the Officer-In-Charge be obtained.
- 20. Security deposit @ 10% of the order value shall be deposited under 15 days of receipt of the order.
- 21. In case of any accident of the hired vehicle or to the driver or any dispute, the responsibility for releasing the vehicle from police/court and related liability/charges etc. shall be borne by the contractor.
