SPECIAL TERMS AND CONDITIONS OF CONTRACT

1. SUBMISSION OF TENDER:

Sealed tender is invited for supply of medicines for various hospitals /dispensaries of Chhattisgarh State Power Companies, from registered Pharmaceutical companies and Authorized Super Stockiest/Authorized Distributor/ Authorized C&F Agent of registered Pharmaceutical companies amongst the 60 enlisted Companies (**Annexure- A**) with Chhattisgarh State Power Companies. The offers must reach to the O/o Chief Medical Officer, CSPHCL, Raipur by the specified time and date as mentioned in tender. Tender received late or delayed on any account will not be considered.

2. EARNEST MONEY DEPOSIT (EMD):

The participating bidder shall required to deposit the Earnest Money Deposit (EMD) amounting to Rs. 5,30,000/-(Rs. Five Lakh only). The EMD can be deposited in form of Bank Demand Draft / Banker's Cheque drawn in favour of **CS Power Holding Co Ltd, Raipur**. No offer shall be accepted without requisite Earnest Money Deposit, and summarily rejected.

3(a) PERIOD OF CONTRACT

The period for contract for supply of ordered medicines shall be **1 (one) year** from the date of order.

3(b) EXTENSION ORDER: -

Extension order of quantity of medicines may be given by Chief Medical Officer, CSPHCL, Raipur on the performance basis of the supplier on the following terms and conditions:

- Extension order for 50 % of total ordered quantity of medicine(s) may be placed on the same rate terms and conditions during the contract period. In order to meet any emergency situation, the contract period may be extended for further period of 4 (Four) months with mutual consebt of ordered firm.
- 2) Price Reduction clause: In case of fresh tender is issued for the same item before completion of supply against the extension order and lower rates are received in the fresh tender, the lower rates received in the fresh tender shall be applicable to the balance quantity of extension order to be supplied.

4. TERMS OF OFFER:-

The bidder shall be required to supply 783 (seven Hundred eighty three) general and 48 (forty eight) proprietary medicines formulation of which are mentioned in the list enclosed, (Annexure-B) normally at an interval of 4 months from the date of order. The offer shall be for each unit of tablet, syrup or vial. The rate quoted shall be excluding GST. The firm should also indicate the rate of GST of individual medicine. 5. PRICE:-

The bidder shall quote **FIRM Price** of the medicines to be supplied on the basis of rates per unit quantity i.e, for each Tab/ vial/ bottle etc in the pages enclosed with tender document only. The Price quoted is exclusive of GST. The GST shall be mentioned separately by the bidder and same shall be paid as per prevailing rate.
