Tender are invited Tender for Purchase and Refilling of Fire Extinguishers Installed in Power Companies Campus, Dangania, Raipur. The terms & conditions of the tender are as under:-

Schedule-I
Terms & conditions

1. Sealed offers are invited from the reputed suppliers of Fire Extinguisher.
2. Offers must be submitted in sealed cover addressed to the O/o. AGM (HR), C.S.P.H.C.L. Raipur with Tender no., the name of work, due date of opening and the name of the tenderer superscribed on the cover.
3. More than one tender shall not be submitted by one firm.
4. Tenderers are required to furnish earnest money amounting ` 9,500/- (Nine Thousand Five Hundred) only in the form of DD/bankers cheque in favor of "C.S.P.H.C.L." Raipur issued by nationalized/scheduled bank.
5. The contractor shall furnish Security Deposit by Demand Draft/Bank Guarantee drawn on nationalized/scheduled bank for an amount equal to 10% of the contract value of the work/contract as a security in favour of CSPHCL, Raipur. No interest shall be paid by CSPHCL on the Security deposit. In case of non-fulfillment of contractual obligations by the contractor, the security deposit shall be forfeited. This Security Deposit will be released after satisfactory completion of contract.
6. The tender shall be submitted to the O/o. AGM (HR), C.S.P.H.C.L. Raipur on or before 08.04.2020 before 12.00 PM. Tender offers received without earnest money will not be considered.
7. The envelope of EMD superscribed "Earnest Money Deposit" will be opened first and verified during opening of tender.
8. The Earnest Money will be refunded to unsuccessful bidder within a reasonable time on request through application. The earnest money deposit shall be forfeited, if the supplier fails to execute the order after acceptance of tender. This forfeiture shall be without prejudice to the right of the company to recover further damage, if any from the tender. No interest on Earnest Money will be paid by the company.
9. Tenderer must return the tender form (Schedule-III) along with Schedule-I and Schedule-II duly filled and signed on the every page of tender. The Schedule-I and II shall be submitted in one sealed envelope duly super scribed as "Commercial Bid". The Schedule-III shall be submitted in another sealed envelope duly super scribed as "Price Bid". All two envelopes put in one envelope duly super scribed Tender specification number and date of opening.

10. The tenderer shall furnish, with the tender, latest income tax clearance certificate issued by competent authority or copy of return filed. Alternatively, the tenderer shall give valid reason for his inability to furnish such certificate. The company reserves the right to reject any tender if the income tax clearance certificated or the reasons for the tenderer inability to furnish such certificate is not furnished.
11. Tenderer which do not fulfill all or any of the above conditions or incomplete tender in any respect are liable to be rejected.
12. The submission of tender by the tenderer implies that the tenderer is ready and has accepted the instruction and conditions of the tender etc.
13. The company will not, after acceptance of order rate, pay any extra charges for any reason what so ever in case the tenderer later on have misjudged the conditions of the order.
14. The tenderer shall quote the rates both in words and figures in the price bid enclosed. Rates quoted in tender shall remain firm throughout the period of order. In case of deviation of rates in figures and words, rates quoted in words only shall prevail.
15. In case, the lowest rate is quoted by more than one firm then successful bidder among the lowest will be decided on the **basis of lottery**. The lottery will be drawn in presence of representatives of the firms. After drawl of lottery no any claim shall be entertained from any of the bidder. A form of undertaking annexed with the tender is to be signed by the tenderer necessarily in this respect.
16. The rates quoted in Percentage will not be considered. The rate should not be quoted in Paise i.e. in decimal of rupees.
17. The tender document shall be returned legible and free from erasure, over writing or conversion of figures. Any correction made should be done in legal manner.
18. It shall not be obligatory for the company or its officers to accept the lowest tender. The authority for the acceptance of the tender will rest with company, which does not bind itself to assign any reason for declining to consider any particular tender or tenders.
19. The tender should be valid positively for acceptance, for a period of three month from the date of opening otherwise it is liable for rejection.
20. Further information required, if any, regarding tender can be taken from the Manager (P&S) O/o. AGM (HR), C.S.P.H.C.L. Raipur.
21. The notice of tender shall form part of the contract and any breach of the terms of this notice shall be deemed to be a breach of contract.

22. All matters arising out of or any way connected with this contract shall be deemed to have arisen in Raipur and only the courts in Raipur shall be the jurisdiction to determine the same.
23. Any deviation from the enclosed terms and conditions should be specially mentioned in the offer, failing which it will be assumed that there is no deviation from the terms and condition, of the tender.
24. The tender received after the due date and time shall not be accepted /opened.
25. The company reserves the right to accept/reject any tender without assigning any reason thereof.
26. Further information required, if any, regarding Fire Extinguishers can be obtain for Chief Fire Officer, C.S.P.G.C.L. Raipur.
27. The maintenance of Fire Extinguishers is to be done periodically by the firm on priority. The Service Engineer/Technician shall attend the Fire Extinguishers in case of any exigency.

Special Terms & Condition

1. **Rates** :- Rates given by bidder should be firm. After approval of tender for placing order firm have no right to change their rates.
2. **Taxes** :- Rates quoted by the bidder shall be exclusive of GST. The GST shall be indicated separately.
3. **Payment** :- 100% payment shall be made after receipt of Fire Extinguisher in good condition and certificate of satisfaction issued by Chief Fire Officer, CSPGCL, Raipur.
4. **Delivery** :- The delivery of New Extinguishers and Refilled Extinguishers made within 15 days from the date of receipt of Blank Extinguishers. Blank Extinguishers issued by Chief Fire Officer, CSPGCL, Dangania, Raipur.
5. **Penalty** :- Penalty for delay in supply & Installation beyond stipulated period shall be Half (½) % per day subject to maximum 10%.
6. **Guarantee/Warrantee** :- Minimum 1 year from Date of Refilling Extinguishers, ABC Extinguishers minimum 5 years and CO2 Extinguishers warranty 2 years and body life 10 years.
7. **Validity** :- 90 days from the date of opening.
8. **Consignee** :- New and Refilled Fire Extinguishers are handed over to Chief Fire Officer, CSPGCL, Dangania, Raipur. After necessary tests and hydraulic tests.
9. **Expiry date of material** :- The material refilled in Fire Extinguishers shall be good for used for 4 years from the date of refilling.
10. Firm should be submitted hydraulic tests and material tests certificate at the supply of material.
