In compliance to the relevant provisions under section 62 and 64 of Electricity Act and of the Chhattisgarh State Electricity Regulatory Commission (SLDC Fees and Charges) Regulations, 2012 and the Chhattisgarh State Electricity Regulatory Commission Terms and Conditions for determination of tariff according to Multi-Year Tariff principles and Methodology and Procedure for determination of Expected revenue from Tariff and Charges) Regulations, 2015 and 2021, Chhattisgarh State Load Despatch Center has submitted a Petition (No.100/2022(F)) for the approval of CSLDC Final True-up of ARR for FY 2021-22, revised ARR for FY 2023-24 and CSLDC Charges for FY 2023-24 along with Final True-Up of Annual Revenue Requirement of FY 2021-22 tariff and fees and charges.

As per above petition, the revenue gap for FY 2021-22 along with carrying cost recoverable in FY 2023-24 is Rs. 1.83 cr. And revised ARR for FY 2023-24 is Rs. 21.38 cr.
