### A. Eligibility Criteria:

- i. (a) Registered Contractor in CSPTCL in A-II & Above for works at Sl.No. 02, 03, 06,
  - (b) Registered Contractor in CSPTCL in A-III & Above for works at Sl.No. 01 & 05.
  - (c) Registered Contractor in CSPTCL in A-IV & Above for works at Sl.No. 04.
- ii. For unregistered contractors – (For Sl.No. 01 to 08)

The bidder should have executed at least (in last 5 years):-

- One civil work/similar works each  $\geq 80\%$  of estimated cost
- Two civil work/similar works each ≥ 50% of estimated cost
- (c) Three civil works/similar works each  $\geq$  40% of estimated cost
- The Bidders shall have valid registration in EPF & ESIC department and submit its iii. proof.
- GST Registration: The contractors have to submit the copy of their valid GST iv. registration.
- Bidder should not have been debarred/blacklisted by the State Govt./Central Govt./State v. PSU/SEB/Power Utility as on the date of opening of tender. A declaration in this regard shall be furnished by the bidder as per format given in Annexure-I on contractors/firms letter head.
- No Joint venture shall be permitted. vi.

#### B. GUIDELINE for participation in E -tender:-

i. Access to Tender Document: - Tender document can be accessed from our e-tender portal. Bid creation / submission can be completed after logon to our e-tender portal using valid LOGIN ID/Password, allotted to vendors.

Please ensure that you have the vendor code, user ID & password. In case you do not have either vendor code, user ID & password, please contact Executive Director (Civil)/EITC department well in time and at least three days before the last date of paying of tender fee.

#### ii. Tender Fee submission- Online :-

- a. Cost of Tender document is to be paid online only, through e-bidding portal of Chhattisgarh State Power Transmission Company.
- b. Bid of the Bidders who have not submitted requisite amount for cost of Tender Document shall not be considered.

#### iii. Bid Submission:-

- a. EMD of requisite amount to be paid online only. Submission of EMD in other form shall be rejected.
- Technical Bid are to be deposited offline in the office of E.D. (Civil), CSPTCL, Raipur in sealed envelope. The envelope should be superscribed with name of work, Tender No., RFx. No., the due date of the tender and name of the tenderer with address. The technical bid comprising of complete tender document comprising Part-I (Front cover page of tender document) & Part-II (remaining pages except front cover page of tender document), errata, NIT, Extension of NIT (if any), Declaration by the bidder on firm's letter head, schedule, copy of valid ESIC Certificate, copy of valid EPF Registration, copy of valid/active GST Registration, Copy of registration of contractor in CSPTCL in appropriate class as per eligibility criteria, Pre contract Integrity Pact, work experience and check list. Checklist alongwith legible printout of all the requisite documents with seal and signature of the bidder are to be submitted manually in a sealed envelope in the O/o E.D. (Civil) by 12:15 Hrs. The checklist, tender document comprising Part-I ( Front cover page of tender document) & Part-II (remaining pages except front cover page of tender document), Errata, NIT, Declaration form, pre contract integrity pact and Schedule can be downloaded from Notes & Attachments of particular RFx. of e-tender portal after submission of requisite cost of tender fee. The contractor is liable for legal action if any of the documents submitted are found tampered.
- c. This is an E-tender and bidders shall **submit price bid & EMD ONLINE**. Price Bids sent in physical form through any other means/media is not at all acceptable & it will be rejected.
- d. Vendors should have valid Class-II/III signing and encryption Digital Signature with sufficient validity to participate in E-Tender.
- e. However, if any short coming is observed during scrutiny of Techno Commercial bid, CSPTCL, reserves the right to seek required clarifications/documents from bidder by giving them only one chance to submit required documents/clarifications/confirmations within specified time limit.

- a. CSPTCL reserves the right to access the capacity of bidders after scrutiny of applications and reserves the right to reject any or all tenders without assigning any reason.
- b. CSPTCL will not be responsible in any way for late submission due to any network delay in any form in transit or breakdown in the internet communication system etc.

#### C. IMPORTANT INSTRUCTION/NOTES FOR E-BIDDING:-

- 1. Only price bid & EMD are to be submitted online. Legible printout of all the supporting documents with seal and signature of the bidder are to be submitted offline in the O/o E.D. (Civil) by 12:15 Hrs. on the due date in sealed envelope constituting Technical Bid listed at B.(iii).b above.
- 2. Please note that this tender is **processed online**, hence the bidder should keep proper record at his end.
- 3. Please note that e-mail is always system generated, hence bidders are advised to regularly check their inbox/junk mail box.
- 4. Price bids are accepted only through online. Hard copy of price bid shall not be accepted.
- 5. CSPTCL shall not assume any responsibility for non-supporting of system, internet, line & associated hardware and software in bidding their tender. No extension in time shall be granted on such grounds. It is strongly recommended not to wait for submission of bid in last minutes as internet/technical problem may disrupt the process of e-bidding.
- 6. Rates should be quoted online & in specified fields only in price bid section of particular RFx. in e-bidding portal. Rate quoted in other place viz. technical/commercial bid section shall be rejected. Once the rates are filled, the bidders may change their rates up to the due date and time of submission of tender. After due date and time, no change on any ground whatsoever will be accepted.
- 7. After deadline, no alteration in the tender will be allowed by the system.
- 8. CSPTCL will not accept incomplete bid.

#### D. GENERAL INSTRUCTIONS:-

- 1. Tender document is available online as an attachment in particular RFx. on e-bidding portal.
- 2. For online submission of bid, the bidder may take online help from e-bidding vendor user manual displayed on website.
- 3. Tenders (Technical Bid & Price Bid) shall be opened in the schedule time as notified. If the due date of opening/submission of tender document is declared a holiday by the Govt./Local administration, it will be automatically shifted to next working day for which no prior intimation shall be given. Tender opening shall be continued on subsequent days, in case of opening of all tenders is not completed on due date because of technical constraints of system on the day of opening. It may be noted that the due date of opening/ time may be altered/extended if desired by CSPTCL without assigning any reason. However intimation shall be available on Company's tender portal /bidders email (to participating bidder). The bidders are requested to keep track of the same.

- 4. Before participating, bidders are advised to read carefully all the instructions and processes in "User manual and instruction document" which is available in <a href="https://ebidding.cspcl.co.in:50724/irj/portal">https://ebidding.cspcl.co.in:50724/irj/portal</a>.
- 5. Further extension of due date of opening of bids, corrigendum etc. and price bid opening date will be informed by e-mail.
- 6. The requisite documents are not to be submitted with the price bid. The requisite documents are to be submitted manually in sealed envelope. EMD should be submitted online only.
- 7. E-mail/Fax/Telegraphic tender offers will not be accepted.
- 8. Enabling for download of tender documents to firm does not make them quality to award the contract.
- 9. The Executive Director (Civil) on behalf of the company shall have right to either accept any of the bid or reject any or all the bids without assigning any reason.
