- Maintenance period is applicable for work mentioned above at Sl. No. 1,5,6,7,8 & 9 is 12 months each and at Sl. No. 2 to 4 is NIL.

B. Eligibility Criteria :-

- Registered Contractor in CSPTCL in A-II & Above for works at Sl. No. 1,7, 8 & 9 ; for Sl. No. 5, registered Contractor in CSPTCL in A-III & Above and for Sl. No. 6 registered Contractor in CSPTCL in A-IV & Above
- For unregistered contractors -
The bidder should have executed at least:-
(a) One civil work each \geq 80% of estimated cost
(b) Two civil work each \geq 50% of estimated cost
(C) Three civil works each \geq 40% of estimated cost
- The Bidders shall have registration in EPF & ESIC department and submit its proof.
- GST Registration: - The contractors have to submit the copy of their GST registration.
- Bidder should not have been debarred/blacklisted by the State Govt./Central Govt./State PSU/SEB/Power Utility as on the date of opening of tender. A declaration in this regard shall be furnished by the bidder as per format given in Annexure-I on contractors/firms letter head.
- No Joint venture shall be permitted.
- For Sl. No. 2, 3, &4, Registered/unregistered Contractors with experience in same nature of works in Govt. deptt/undertaking.

C. GUIDELINE for participation in E-tender:-

- i. **Access to Tender Document:** - Tender document can be accessed from our e-tender portal. Bid creation / submission can be completed after logon to our e-tender portal using valid LOGIN ID/Password, allotted to vendors.
Please ensure that you have the vendor code, user ID & password. In case you do not have either vendor code, user ID & password, please contact Executive Director (Civil)/EITC department well in time and at least three days before last date of paying of tender fee.
- ii. **Tender Fee & EMD Document Submission – Online :-**
 - a. Cost of Tender document & EMD are to be submitted online only through e-bidding portal of Chhattisgarh State Power Transmission Company.
 - b. Bid of the Bidders who have not submitted requisite amount for cost of Tender Document and EMD shall not be considered.

- iii. **Bid Submission:-**
 - a. This is an E-tender case and bidders shall submit bid ONLINE only. Bids sent in physical form through any other means/media is not at all acceptable & it will be rejected.
 - b. In confirmation of acceptance of tender conditions, complete tender document, errata, NIT, Declaration by the bidder on firms letter head and schedule along with all supporting documents, are to be attached in Rfx information Tab > Notes and Attachment > Attachment for techno commercial bid> Add attachment, with your digital signature; during bid creation process. The contractor is liable for legal action if any of the documents submitted are found tampered.
 - c. Vendors should have valid Class-II/III signing and encryption Digital Signature with sufficient validity to participate in E-Tender.
- (iv) **Help desk (problem related with Login ID in e-bidding process):-**

- b. CSPTCL will not be responsible in any way for late receipt of online cost of tender document fee/EMD & e-bids due to any network delay in any form in transit or breakdown in the internet communication system etc.

D. IMPORTANT INSTRUCTION/NOTES FOR E-BIDDING :-

1. Please note that this tender is exclusively and entirely processed online, hence the bidder should keep proper record at his end
2. Please note that e-mail is always system generated, hence bidders are advised to regularly check their inbox/junk mail box.
3. Bids are accepted only through online. Hard copy of bid shall not be accepted.
4. CSPTCL shall not assume any responsibility for non-supporting of system, internet, line & associated hardware and software in bidding their tender. No extension in time shall be granted on such grounds. It is strongly recommended not to wait for submission of bid in last minutes as internet/technical problem may disrupt the process of e-bidding.

5. Rates should be quoted online & in specified fields only in price bid section. Rate quoted in other place viz. technical/ commercial bid section shall be rejected. Once the rates are filled & locked, no change on any ground whatsoever will be accepted
6. After deadline, no alteration in the tender will be allowed by the system.
7. CSPTCL will not accept incomplete bid.

E. It is mandatory to submit:-

1. Detailed NIT, complete tender document, Errata, declaration by the bidder on letter head as per proforma appended as Annexure-I, Schedule, EPF, ESIC, GST, Copy of registration of contractor in CSPTCL in appropriate class as per eligibility criteria, work experience copy and related supporting document if any.

F. GENERAL INSTRUCTIONS:-

1. Tender document will be displayed in online tender display at Technical RFx section.
2. For online submission of bid, the bidder may take online help from e-bidding vendor user manual displayed on website <http://ebidding.cspcl.co.in:50724/irj/portal>.
3. Tender shall be opened in the schedule time as notified. If the due date of opening/submission of tender document is declared a holiday by the Govt./Local administration, it will be automatically shifted to next working day for which no prior intimation shall be given. Tender opening shall be continued on subsequent days, in case of opening of all tenders is not completed on due date because of technical constraints of system on the day of opening. It may be noted that the due date of opening/ time may be altered/extended if desired by CSPTCL without assigning any reason. However intimation shall be available on Company's tender portal /bidders email (to participating bidder). The bidders are requested to keep track of the same.

5. Further extension of due date of opening of bids, corrigendum etc. and price bid opening date will be informed by e-mail.

7. If the documents are shown attached in bid but due to any reason could not be opened, another copy will be accepted by email on request of CSPTCL.
8. E-mail/Fax/Telegraphic tender offers will not be accepted.
9. Enabling for download of tender documents to firm does not make them quality to award the contract.
10. The Executive Director (Civil) on behalf of the company shall have right to either accept any of the bid or reject any or all the bids without assigning any reason.
