The Participating vendor should be registered vendor in T&D wing of power companies of Chhattisgarh State.

The bidder whose material has not found up to the mark in previous order of power companies of CG State shall not be eligible in instant tender.

The tender in the prescribed form with Earnest Money of **Rs 2,800/- (Rs Two thousand eight hundred)** only, in the form of Demand Draft favoring the **Manager (RAO-HQ), CSPTCL, Raipur** shall be **accepted up to 15.00 Hrs** on or before dated 26-08-21 and will be **opened on the same day at 15.30 Hrs** before the tenderer wish to be present. In case a holiday is declared by the Govt. on the schedule date, the last date for submission and opening of tender will automatically be shifted on the next working day. No offer will be accepted without Earnest Money and will be rejected. The EMD submitted by un-successful bidders shall be returned to them after finalization of the tender whereas the EMD in respect of L-1 bidder after furnishing the required Security Deposit.
