The tender in the prescribed form with Earnest Money of **Rs 4000/- (Rs Four thousand)** only, in the form of Demand Draft favoring the **Manager (RAQ-HQ), CSPTCL, Raipur** shall be **accepted up to 15.00 Hrs** on or before dated **07-09-21** and will be **opened on the same day at 15.30 Hrs** before the tenderer wish to be present. In case a holiday is declared by the Govt. on the schedule date, the last date for submission and opening of tender will automatically be shifted on the next working day.
