- 03. Copies of the vehicle registration Book / Insurance / Driver License / Commercial tax, paid proof GST registration, EPF & ESIC registration etc. shall be submitted at the time of execution of agreement.
- 04. The rates are quoted in the proforma enclosed with the enquiry in two Categories.
 - i) Fixate for running of 2000 Kms per month.
 - ii) Per Kilometer rate for running beyond 2000 Kms.
- 05. Rate quoted may be inclusive of driver's salary Diesel, lubricant, all R&M charges of vehicle and road taxes etc.
- 06. GENERAL TERMS& CONDITIONS FOR THE TERNDERES

- 01. The rate for vehicle on hire be given inclusive of cost of fuel lubricant, drivers salary R&M of vehicle Insurance taxes of vehicle (Road, Tax, Commercial Tax, etc.)
- 02. The Vehicle should possess valid papers like Registration / Insurance and commercial tax paid. Any charges with regard to the same be coming payable would be owner's responsibility.
- 03. During the contract the vehicle owners shall be responsible for making payment for accident / damage / injuries to his driver / outsider.
- 04. The vehicle may be freed for not more than 24 hours in a month for repairs and maintenance and if time taken more that 24 hours a substitute arrangement shall be made by the vehicle owners, if not, necessary deduction in the bill shall be effected, as per prevailing rates for absence.
- 05. The undersigned reserves the right to make substitute arrangement on his discretion for driving the vehicle by company driver or other driver, on owner's risk. A deduction @ Rs.345/- per day would be made in the bill accordingly.
- 06. The vehicle shall be kept round the clock, in Board's custody only.
- 07. Whenever the vehicle goes out of station tour allowance or meals etc. whatever becoming payable to its driver shall be paid by the vehicle owners.
- 08. A logbook shall be maintained by the OIC and the payments shall be made on the basis of certificate issued by the officer-in-charge.
- 09. A regular check of milometer shall be conducted by the OIC, at a certain interval.
- 10. The payment against the bill for a completed month shall be made through the R.A. O. CSPTCL, Raipur.
- 11. The payment for extra runnage beyond the 2000Kms. Limit will be clubbed and be made on the basis of monthly average fixed by the company.
- 12. Deduction for lesser runnage with reference to prescribed limit shall be made @5.90 per Km. on quarterly basis.
- 13. Toll tax coming payable shall be borne by the Board/Company.
- 14. If any expenditure is incurred on the vehicle by the company shall immediately be deducted from the bills.
- 15. The driver engaged by the vehicle contractor/owners shall be at AE:EHT(Maint.)S/Dn. CSPTCL Bemetara and his address be registered in this office. It is obligatory on the vehicle contractor/owners's part that the driver should posse's amicable behavior..
- 16. The EE (EHT-Maint)Dn., Bhilai reserves the right to terminate/discontinue the contract by giving one month notices summarily without assignment any reason.
- 17. The engaged driver shall be attend duty on Gray Color dress & dress has provided by the owners of vehicle.
- 18. The monthly hire charges of Engaged vehicle for 2000 Km monthly run and additional charges for excess run & over and above the 2000 Km/month should be quoted by contractor consider the following
 - a) GM(HR),CSPHCL order no. 01-02/veh/revision/3629 Raipur dt. 05/11/2019.
 - b) Fuel prices @ Rs.96.65 as per ED(Fin.)CSPHCL Raipur circular No.05-01/F&A/1428 Raipur Dt. 29.10.2021
 - b) Driver wages @ Rs.10710/- per month applicable for period 01.10.2021 to 31.03.2022 as per notification of labour commissioner.
 - c) Addition <u>EPF@13.00</u>, <u>ESIC@3.25%</u> Bonus @8.33%. of the notified wage by the labour Commissioner Govt. of CG.
- 19. Revision in hiring charges of contract positive or negative will be permitted for any change in the minimum wages of driver, EFP/ESIC/Bonus rates and fuel prices with respect to, as the case may be, the driver wages, statutory payment rates and fuel price in force on the date of opening of bids, as follows:-

- (A) Revision (Upward of downward) on account of change in the price of fuel: 83 paise per km for change in the price of fuel by Rs. 10(Ten) per liter. This revision will be allowed at the end of each of the four quarters (1st quarter of a financial year will commence from 1st April of the FY) based on the average fuel price for the relevant quarter. The average fuel price for each quarter will be posted in the Power companies' website by the G.M. (Finance), CSPHCL. In the event of part quarter, i.e. the quarter in which date of commencement or conclusion of contract falls, no variation shall be allowed if part-quarter covered by the contract is less than 45 days. If the part-quarter is equal to or more than 45 days , the average fuel price posted for the quarter.
- (B) Revision on account of revision in minimum wage of driver: Additional payment due to revision in minimum wages

=[(L2-L1)x Days of run as per contractor] /

[Number of days in the month]

- Where:- L1= Monthly minimum notified wage of driver on the date of opening of tender
 - L2= Monthly minimum notified wages of driver of the month for which payment is to be made.
- (C) Revision on account of EPF, ESIC and bonus:
 - Additional payment= [(L2-L1) x0.2458xDays of run as per contract] / [Number of days in the month]
 - **Where:-** L1= Monthly minimum notified wage of driver on the date of opening of tender.
 - L2= Monthly minimum notified wage of driver of the month for which payment is to be made.

The factor 0.2458 is based on the current rates of <u>EPF@13.00%</u>, <u>ESIC@3.25%</u> and <u>Bonus@8.33%</u>, totaling to 24.58%. In case any of the rates is revised the factor will get change accordingly.
