- 101. The rate for vehicle on hire be given inclusive of cost of fuel lubricant, drivers salary R&M of vehicle Insurance taxes of vehicle (Road, Tax, Commercial Tax, etc.)
- O2. The Vehicle should possess valid papers like Registration / Insurance and commercial tax paid. Any charges with regard to the same becoming payable would be owner's responsibility.




