
Tender documents (tender form, terms & conditions etc.) can be purchased on payment of **Rs 590/- (including GST@18%) (Rs Five hundred ninety)** only in Shape of DD/ PO (non refundable) payable at Raipur, in favour of **Manager (RAO-HQ), CSPTCL, Raipur** from the office of the under-signed on or before **28.12.2021 up to 15.30 Hrs.** Postal charges worth Rs 200/- (Rs Two hundred) only should also be sent in advance by PO/ DD, by those tenderer who desire to obtain the tender documents by post. The request to send the tender documents through post may reach this office well before 10 days from the date of submission of tender documents.

The Participating vendor should be registered vendor in T&D wing of power companies of Chhattisgarh State.

The bidder whose material has not found up to the mark in previous order of power companies of CG State shall not be eligible in instant tender.

The tender in the prescribed form with Earnest Money of **Rs 3,000/- (Rs Three thousand)** only, in the form of Demand Draft favoring the **Manager (RAO-HQ), CSPTCL, Raipur** shall be **accepted up to 15.00 Hrs** on or before **dated 29.12.2021** and will be **opened on the same day at 15.30 Hrs** before the tenderer wish to be present.
