

The request to send the tender documents through post may reach this office well before 10 days from the date of submission of tender documents.

The Participating vendor should be registered vendor in T&D wing of power companies of Chhattisgarh State.

The bidder whose material has not found up to the mark in previous order of power companies of CG State shall not be eligible in instant tender.

The tender in the prescribed form with Earnest Money of **Rs 1,500/- (Rs One Thousand Five Hundred)** only, in the form of Demand Draft favoring the **Manager (RAO-HQ), CSPTCL, Raipur** shall be **accepted up to 15.00 Hrs** on or before **dated 29/12/2021** and will be **opened on the same day at 15.30 Hrs** before the tenderer wish to be present.
