

Postal charges worth Rs 200/- (Rs Two hundred) only should also be sent in advance by PO/ DD, by those tenderer who desire to obtain the tender documents by post. The request to send the tender documents through post may reach this office well before 10 days from the date of submission of tender documents.

The Participating vendor should be registered vendor in power companies of Chhattisgarh State.

The bidder whose material has not found up to the mark in previous order of power companies of CG State shall not be eligible in instant tender.
