Terms & Condition

- 1. The rate is to be quoted per MT / per Cu Mtr. / per Nos/ per tower each items as per details given on the proforma-I and if there is any over writing/ cutting that should be attested with seal and signature of the contractor, otherwise the offer will be rejected, which may be noted.
- 2. The rates should be quoted for labour charges inclusive of all charges and for at site but excluding service tax.
- 3. The contractors may be advised to gather all information about terrain of the site before participation in tender to assess the actual work involved and avoid any dispute in future.
- 4. Before starting the work, the contractor will have to intimate the concerned OIC of the work.
- 5. The OIC of the work will be AE EHT (Maintenance) S/Dn. CSPTCL Gurur under whose supervision or his authorized representative, the work will have to be completed.
- 6. The A-Class valid Electrical contractor license with permission of authorization for all work involving EHT lines above 33KV issued by CG Anugyapan Mandal valid labour license and necessary labour insurance certificate should be submitted by the contractor before commencement of work to the OIC of the work.
- 7. The work should be completed within 15 days from the order by the contractor. All safety arrangement and instruction of the EE EHT (Maintenance) Dn. CSPTCL Bhilai or their authorized representative should be followed. The contractor has to arrange all safety appliances etc to their labour & safety rule should be followed strictly.

8. Insurance

- a) The responsibility for the safety and security of the line materials rest on the contractor, thus the contactor is to ensure it as they are custodian of all the materials issued to them for the execution of the work.
- b) In case of theft/damage of the CSPTCL materials from contractors site store/ during transportation of materials, it is sole responsibility of the contractor to lodge FIIR in concerned Police station immediately and intimate it to the Engineer-in-charge/ OIC of the work within 24 hours and ensure to lodge claim before concerned insurance company where the materials were already insured for all such purpose under intimation to CSPTCL the entire cost of materials lost due to theft or damage will be recovered from the contractor.

- c) The contractor shall arrange insurance coverage for the men and materials at his custody and line under execution and shall keep it ensured against loss by theft, destruction or damage by fire, flood, undue exposure to the weather or through riot, civil commotion, war or rebellion, for the full value of the line till the time of delivery until the line is taken over as per relevant clause of this specification. This insurance shall also cover by theft at site/line.
- d) The bidder shall ensure following insurances also:
 - i) Workmen compensation Insurance: This shall protect against claims applicable against workmen's compensation Act 1948 (Govt. of India). This liability shall not be less than

- ii) Comprehensive Automobile Insurance:- this insurance shall be in such a form to protect the contractor against all claims for injuries, disability, disease and death of members of public including purchase men and damage to property of others arising from use of motor vehicle during on or off the site operation irrespective of ownership of such vehicles.
- f) Comprehensive General liability insurance: It shall protect contractor against all claim arising from injury disability, disease or death of public or damage to property due to act of contractor or his representative.
- 9. The work will be carried out by observing all the rules and regulations regarding safety and any type of accident which of takes place would be the contractor's responsibility. The contractor shall be responsible for payment of all compensation as applicable from time to time to their workmen engaged on the work in the event of any accident. The necessary insurance certificate of labour should be submitted by the contractor before commencement of work to the OIC.
- 10. As per the statutory obligation under PF Act as amended, the contractor will have to furnish full particulars of PF / EPF / EDCEL contribution in respect of employees engaged.
- 11. The payment of labour should be done / paid as per Govt. / collector rate before CSPTCL's representative and concerned Division should ensured compliance of CSPTCL's circular.
- 12. Rule and regulation should strictly be followed by the contractor and their labour engaged on the work.
- 13. The EE (EHT:Maint) Dn., CSPTCL, Bhilai reserves the rights to accept offer or amend / cancel this enquiry without assigning any reason.
