2. Sealed Tenders are invited on three part basis, One envelope containing the E.M.D. and clearly super-scribed "Earnest money" on Top. In case, the tender has been downloaded from CSPTCL's official website, the cost of tender document in the form of DD in favour of Manager (RAO-HQ), CSPTCL, Raipur be submitted along with the tender in EMD envelope. - 8.02 An amount equal to 10% of the value of the order i.e. **Rs. 1,90,000/-** is to be deposited by the successful bidder towards security deposit within 10 days from the date of issue of the order in the form of DD/FDR dully pledged in favour of Manager, (RAO-HQ) CSPTCL, Raipur Or in the form of Bank Guarantee in favour of Chhattisgarh State Power Transmission Company Limited, Raipur which shall be valid for a period of 18 months from the date of order. - 8.04 The security deposit shall be released only after due and faithful execution of the order as per terms and conditions and after issue of No dues certificate by OIC of the awarded work provided the Executive Director (C&LM) CSPTCL, Raipur is satisfied for the same after receipt of application by the contractor for refund of the Security Deposit.
- 9. 11. **RULES FOR FIRMS:**

If tender is submitted by any proprietary concern it shall be signed by the proprietor only. In case of Registered Company, the seal of the company shall affixed over the signature of one or more Directors as may be provided in the Articles of Association along with a true copy of Memorandum of Association and Articles of Association with authorization to sign tender documents. In case of any partnership true copy, of deed of partners unless otherwise authorized by the deed of partnership in which case necessary power of attorney shall be furnished.

- 12. Tenders which do not fulfill all or any of the above conditions or are incomplete in any respect are liable to be rejected.
- 13. (a) Before submitting the tender, bidders shall be deemed to have full knowledge of all relevant documents and to have satisfied himself by actual inspection of hospital that all conditions liable to be encountered during the execution of supply are taken into account and that the rate(s) be quoted in the tender forms are adequate and all inclusive to accord with the provisions of general/special conditions of contract for the completion of the work to the satisfaction of the Executive Director (C&LM) CSPTCL, Raipur.
 - (b) The submission of a tender by the bidder implies that he has read and accepted the instructions, the conditions of contract etc. and has made himself aware of the scope and specification of the supply to be done and local conditions and other factors bearing on the execution of the supply.
 - (c) The CSPTCL will not pay extra charges for any reason whatsoever after acceptance of contract rate in case the contractor is found later to have misjudged the conditions.
- 14. The tender document shall be written legibly and free from erasers overwriting or conversions of figures. Any corrections if unavoidable shall be made by crossing out initialing dating and rewriting.
- 15. The contract or any part thereof shall not be sublet without the written permission of this office.
- 16. It shall not be obligatory for the CSPTCL or its officers to accept the lowest tender. The authority for the acceptance of the tender will rest with the CSPTCL which does neither bind itself to accept the lowest or any other tender nor does it under take to assign any reasons for declining to consider any particular tender or bidders.
- 17. Canvassing or support in any form for the acceptance of any tender is strictly prohibited. A list showing the names of the persons who are working with the contractor and are near relatives to any officers/employees in the CSPTCL should also be appended with the tender.
- 18. Tenders shall remain open for acceptance subject to the provisions of clause-16 above for a period of Six months from the date on which they are due for submission in accordance with clause-4 above or any other extended date for their receipt and during the said period will entail forfeiture of the earnest money deposited with the tender.

20. **PRE-BID QUALIFICATION**:

The bidders should submit notarized copies of the following certificates:

24. **TERMS OF DELIVERY:**

The terms of delivery shall be as specified in the schedule of the tender.

25. ELIGIBILITY OF CRITERIA FOR SUBMITTING TENDER:

The bidder shall be financially sound. Their Minimum average annual turnover during the preceding 3 years (2017-18, 2018-19, 2019-20) should be Rs. 19.00 lakh. 26. FORFEITURE OF SECURITY DEPOSIT IN CASE OF FAILURE:

In such case, the Security Deposit of the Contractor shall stand forfeited and be absolutely at the disposal of the CSPTCL without prejudice to the right to recover any further amount by way of damages.

27. **SUBMISSION OF BILL:**

The contractor shall submit the bills of the medicines indented during the whole month in quadruplicate showing the details of supplies made against the indents. The contractor shall submit a certificate with each supply indicating that the medicines supplied by them is strictly in accordance to the indent and medicines supplied are Ethical (Branded) medicines only. Payment of the bills presented in

complete form will normally be arranged in three or four weeks from the date of presentation. However no claim shall be made by the contractor against CSPTCL in respect of interest or damages in case the payment is delayed for any reason whatsoever. 29. **ARBITRATION:**

SEHEDULE-1 SPECIAL CONDITIONS OF CONTRACT

1. **PERIOD OF CONTRACT:**

The period of contract shall be one year from the date of acceptance/commencement of day of day requirement of Ethical (branded) medicines or fulfillment of order value i.e. Rs. 19.00 Lakh whichever comes earlier. However, tendering Authority reserves the right to place an order for additional quantity within 06 months from the date of completion of order on the same rate accepted, terms and conditions for further period of three months.

2. TERMS OF OFFER:

The quotation should be for the percentage of discount on the Maximum Retail Price (M.R.P.) since the MRP of the medicines changes frequently therefore discount offered by L-1 bidder will be deducted from MRP printed on packing of respective medicines instead of MRP Price list. The Maximum Retail Price means the manufacturer's notified Maximum Retail Price (M.R.P.) and shall be inclusive of all levies/taxes and surcharges.. The total annual supply of medicines for the period of contract may be about Rs. 19 Lakh (Rs. Nineteen Lakh), but no guarantee can be given as to the maximum value/quantity which will be drawn against this contract whereas you will supply such quantities/articles as may be ordered / indented during the period of contract. The tender shall remain valid for one year from the date of acceptance/commencement of supply of medicines and extended period. The offer submitted by bidder shall be valid for a period of 90 days from the date of opening of bid.

3. **SPECIFICATIONS**:

The supplies are to be made strictly as indicated in the prescriptions/indents with reference to the brand, strength, specification & quantities except as otherwise permitted under relevant clause of this schedule. The supplies shall strictly comply with the stipulations or the Drugs Act, 1940 and Rules made there under and amended from time to time.

4. <u>SUPPLIES WHEN NOT AVAILABILITY OF ANY INDENTED</u> <u>MEDICINES IN THE MARKET:</u>

In the event of non availability of any indented medicines, the substitute medicines may be procured only in consultation with the doctor who has submitted the indent. The substitute medicines supplied by the contractor according to their will/choice shall not be accepted.

All the medicines to be indented should be Ethical Branded and shall be product of enlisted 62 pharmaceutical companies (Annexure-C) approved by the Company. Supplier/their representative shall collect the indent from consignee, after telephonic intimation for the same.

5. <u>LIFE PERIOD</u>:

The life of the Ethical (Branded) medicines supplied should not be less than 04 month at the time of supply otherwise it will not be acceptable and action as deemed fit in the matter will be taken up.

6. **IDENTIFICATION OF MEDICINES:**

The supplier shall submit Original Price List/Maximum Retail Price, Original Product list/ Therapeutic Index if required for the purpose of identification of supplied Ethical Branded Medicines.

7. **PACKING:**

Supplies are to be made in original packing of manufacturers and in only the smallest packing approximately nearest to the total quantity indented, of any particular medicines/drugs on any particular day, by the Addl. CMO, CSPTCL Dispensary, Bhilai-3 unless otherwise stipulated.

8. **LOOSE SUPPLIES:**

Loose supplies are to be made only when the difference between the quantity actually required and the quantity contained in the nearest original packing exceeds the limit of 10% of the indent. The bill for loose supplies shall be calculated on proportionate basis with reference to the price of the nearest higher packing marks by the manufacturer, where the quantity actually does not itself for an original manufacturer's packing.

9. COLLECTION OF PRESCRIPTIONS/INDENTS FOR SUPPLY:

Prescriptions / indents on the basis of which supplies are to be made shall be collected by the contractor or his authorized representative from CSPTCL Dispensary at Bhilai-3 at the specified time as may be indicated by the Addl. CMO, CSPTCL, Dispensary, Bhilai-3.

However, the Addl. CMO, Dispensary, Bhilai-3 will be at liberty to indent medicines require for emergency purposes at any time. The contractor shall, supply such medicines immediately i.e. on the same day itself. The Addl. CMO, CSPTCL, Dispensary, Bhilai-3 will depute a person from his office to collect such medicines.

10. PERIOD UPTO WHICH DELIVERY ORDER WILL BE PLACED:

Supply order, prescriptions/indents, shall be placed till the last day of the contract order received during the closing date shall be completed in the course in accordance with the terms of the contract even though the last date of contract may have expired on the date of supply. Further, the CSPTCL reserves the right to extend the contract for further period of three months on same rate, terms & conditions.

11. **DELIVERY OF MATERIAL:**

The supplier shall supply only Ethical (Branded) medicines only within 24 Hrs on receipt of indent from the In-charge of the Hospitals. In case the supplier does not medicines within indented stipulated 24 REMBURSEMENT THROUGH CONTRACTOR (R.T.C.) procedure will be followed. In this procedure the Patient to whom Medicines which are not available & has been prescribed by the Doctor of CSPTCL, will purchase the medicines from open market and will submit its Cash Memo with "Non Supply Slip" to the In-charge of the Dispensary. On weekly basis the supplier / his representative has to visit to the Dispensary and reimburse the amount of the cash memo submitted by the patient on proper verification by the In-charge of Dispensary. Further the supplier will claim the amount of these cash memo in his next bills and have to enclose all the cash memos of the patient with his bill. Payment of the cash memos to the supplier will be done after the deduction of double the discount quoted by him in his tender conditions on M.R.P. only. If the supplier does not reimburse the amount in time, In-charge of the Dispensary shall be empowered to deduct this amount from the next bill of the supplier.

NO GENERIC MEDICINES/MEDICINE OF GENERIC GROUP/BRANDED GENERIC NON PROMOTINAL BRANDED MEDICINE WILL BE ACCEPTED.

12. MEDICINES REQUIRED IN EMERGENCY:

In some of the cases medicines required in emergency, will have to be supplied on demand. If, the supply of emergency medicines is not made on working days, then Addl. CMO, CSPTCL, Dispensary, Bhilai-3 may purchase the medicines from the local market and payment would be regulated as per clause-11.

13. **WARANTY:**

The bidders shall furnish along with their quotations the under noted warranty.

"The contractor shall supply the medicines/drugs in accordance with the specification as indented and if the articles are discovered not confirming to the prescription/indent or the quality of the said medicines/drugs have deteriorated, the purchaser shall be entitled to reject the said articles or such portion thereof, as may be discovered not to be confirming to the said description of quality. The decision of the Addl. CMO, CSPTCL, Dispensary, Bhilai-3 regarding non-conformity or deterioration in quality shall be final and binding. On such rejection, such articles or such portions thereof as the Addl. CMO, CSPTCL, Dispensary, Bhilai-3 may decide, shall be replaced forthwith failing which the contractor shall be deemed to have committed a breach of contract & they shall be liable to pay such damages as may arise by reason of breach of the conditions of the contract or as the Addl. CMO, CSPTCL, Dispensary, Bhilai-3 may decide without prejudice to any other rights of the purchaser in that behalf under the contract or otherwise."

14. **SATISFACTORY AND DUE PERFORMANCE:**

The prompt & timely supply of the required medicines in specified/required quantity as per requisition and according to the indent/prescription shall be deemed to be essence of the contract. The contract shall be liable to be terminated at any time, without notice, or suitable action will be taken as per discretion of the Company in case of unsatisfactory service or undue delay in supply of the required quantity of medicines/drugs indented or stoppage of supply accordingly. In that event, the amount of Security Deposit shall be forfeited.

- 15. <u>LIQUIDATED DAMAGES</u>:- In the event of partial/non supply of the medicines by the supplier, the Company shall procure such medicines from other sources at the risk and cost of the supplier, and shall be deducted double the offered discount along with taxes and duties from their bills against the partially/not supplied medicines.

- 1) Extension Order may be placed, limited to maximum 50 percent of original quantity during contract period, and contract period may be extended for a period of three month.
- 2) The rates to be offered against the extension order shall be the rates applicable against the main order or the rates, which have now become available against fresh tender, whichever is lower. Thus following price reduction clause shall prevail.

In case of fresh tender is issued for the same item before completion of supply against extension order and lower rates are received in the fresh tender.

The lower rates received in the fresh tender shall be applicable to the quantity of extension order also balance to be supplied.
