In reference to this office NIT No. TR-481/3280 dtd. 18.03.2021 for the work **2nd circuiting of 132 KV Banari-Seorinarayan line on labour contract basis when one circuit is live (R. L.- 19.21 KM approx.)**, the tender clause 2 (ii), 2 (iii) & 2 (iv) of Section I, PRE-BID QUALIFICATIONS / REQUIREMENTS is amended as here under:
