## 9 **SUBMISSION OF TENDER :**

Sealed Tenders are invited on three part basis, One envelope containing the E.M.D. clearly super-scribed “**Earnest money**” on Top. In case, the tender has been downloaded from CSPTCL’s official website, the cost of tender document in the form of DD in favour of Manager (RAO:HQ), CSPTCL, Raipur be submitted along with the tender in EMD envelope. In absence of same, the tender shall not be opened. The bidders who download the documents are requested to remain in contact with this office for any development in the tender.

Second envelope clearly super-scribed “**Techno-commercial Bid**” should contain the tender form, Techno-commercial details and other documents.

Third envelope should contain the price bid clearly super -scribed “**Price Bid**” on Top. All the three envelopes shall be kept in one sealed envelope addressed to the Executive Director (C&LM), CSPTCL, Raipur with the name of work, tender specification number, due date of tender, amount & mode of E.M.D. and name of the bidder super-scribed on the cover. The offer should be dropped in tender box, kept in the office of ED (C&LM) CSPTCL, Dangania, Raipur (CG).

## 10. **OPENING OF BID**

Tenders will be opened in the office of ED (C&LM), CSPTCL, Dangania, Raipur (CG) 492013, in the presence of participant bidders or their authorized representatives (limited to two persons only with a valid authorization from their employer). The Bidders/ their representative shall sign a register / sheet in evidencing their attendance.

The offer shall be opened in the following manner:-

Part – I Envelope –I Earnest money

Part – II Envelope –II Qualifying Requirement &Techno Commercial Bid

Part – III Envelope –III Price Bid

11. At the time of opening of the Part-I and Part-II i.e. Earnest money & Qualifying Requirement, Techno Commercial Bid of the offer, shall be opened on due date as indicated in tender notice in chronological order. If the earnest money and tender form are found satisfactory, then the qualification requirement and techno-commercial bid shall be opened. All the relevant details will be read out.

Price bid of successful Techno- commercial bidders would be opened at a later date with due information to the qualifying bidders.

## 12. **PRICE BID**

The bidder must quote their Prices in the proforma given in the Schedule-III of the tender. Bidders must quote their price in accordance to the specifications and conditions. Any deviation from the above shall be

considered as an alternate bid. The bids will be evaluated based on the main offer only.

- (i) Over-writing, erasures and other changes shall bear the dated initial of the person signing the tender.
- (ii) In the event of discrepancy or arithmetical error in the schedule of price, the unit price shall prevail and the total price shall be accordingly corrected by the CSPTCL. The above arithmetical correction shall be accepted but the decision of CSPTCL shall be final and binding on the bidder.
- (iii) For evaluation the price mentioned in words shall be taken if there is any difference in figures and words in the price bid.
- (iv) The quoted price should be kept valid for the contractual period or completion of the work which ever is later. Bidders are requested to **quote FIRM price inclusive of all taxes & duties except GST. While quoting prices bidders should consider benefit of Input Tax Credit (ITC) available under GST Act and passing same to CSPTCL.**
- (v) All columns shall be completely filled up properly and neatly.
- (vi) The tenders should be kept valid for a period of 180 days from the date of opening of the tenders as notified in the tender notice. In case of extension in due date of opening, the validity period shall be counted from extended due date on which TC bid has been opened.

**13. EVALUATION OF BIDS: -**

- (i) The evaluation of bids will be done by comparing the total of prices of all the items, which are needed for transportation.
- (ii) The loading of the items for which the prices are not quoted by bidders. In such cases the loading will be done at highest price quoted among the bidders. But the orders will be placed at the lowest price offered among the bidders.
- (iii) The CSPTCL reserves the right to reject the lowest or any other tenders or all tenders without assigning any reason, whatsoever, if it is considered expedient in the overall interest of CSPTCL.

The CSPTCL's decision in such matter shall be final.

**14. NON RESPONSIVE BID**

CSPTCL reserves the right to reject any bid, which is:

- (a) Not accompanied by the Earnest Money as specified above.
- (b) Not received by the due date and time specified.
- (c) In variance with specified terms and conditions.
- (d) If at any time, it is found that a material misrepresentation of the fact is made or uncovered.
- (e) The bidder does not respond promptly and thoroughly to the request for supplementary information required for the evaluation of his bid.
- (f) If the bidder fails to super scribe on the envelope containing the bid, the details of Earnest Money deposited by him, the company shall not accept any responsibility and the offers received shall be rejected and shall be returned to the bidders.

- 15. Tenderers must fill-up complete tender form and should submit in original duly signed in all pages by the authorised person of the firm. The document

should be free from over writing. Any tender not bearing the signature in all the documents accompanying the tender shall be liable for rejection. Bidder should also submit following documents, if applicable:

- (a) Labour licence.
- (b) Income tax details along with PAN
- (c) GST Registration.
- (d) EPF Registration.
- (e) Employee Security Insurance.

16. It will be the sole responsibility of the bidder to make sure that all the documents required as per tender are submitted alongwith bid on or before due date of tender. However, if any short coming is observed during scrutiny of TC bid, CSPTCL reserves the right to seek required clarifications/confirmations within specified time limit.



**SECTION –II**  
**GENERAL TERMS AND CONDITIONS**

1. The rate is to be quoted as per details given in the Annexure-I, i.e. Offer Form/Price bid and if there is any over writing / cutting on the same should be attested with seal and signature of the bidder, other wise the offer will be rejected which may be noted.
2. The rates should be quoted inclusive of all the charges and FOR at site but **excluding GST**. The liability of GST shall be borne by CSPTCL and the same will be paid directly to concerned department. The loading of GST on offered price may vary depending on the GST rate declared by the Government from Time to Time.
3. The rates should be quoted per job basis for loading / unloading, shifting / dragging and transportation of Transformer with oil and accessories from 132/33 KV S/s Patan to 132/33 KV Sub-station, Mohla. The transit insurance of Transformer with oil and accessories will be arranged by the contractor and produced before CSPTCL prior to taking up transportation work.
4. The required 20 MVA EMCO make 132/33 KV transformer with oil and accessories will be provided by the CSPTCL. The contractor has to drag 20 MVA transformer and load on trailer at 132/33 KV S/s Patan by deploying their own facility after ensuring all safety arrangements, transport the same to 132/33 KV Sub-station, Mohla and unload & place on the plinth. The required T&P such as crane, chain pulley block, steel wire, rope, derrick, sleepers etc. shall be arranged by the contractor for executing the work against the tender. The dragging / shifting /transportation of transformer should be done as per requirement at 132/33 KV S/s Patan and 132/33KV Sub-station, Mohla.
5. The transit insurance of Transformer with oil and accessories will be arranged by the contractor. The contractor shall arrange the insurance for 43 MT Transformer with oil and 12 MT accessories which is expected to be in transit or in the custody of the contractor during the transportation. The cost of 43 MT Transformer with oil and 12 MT accessories will be Rs. **53,02,262/-** for the purpose of insurance. The Transformer with oil & accessories will be issued to the contractor only after insurance of the said materials and submission of insurance certificate to the OIC for execution of the transportation works. The quoted prices shall be inclusive of such insurance charges.
6. The work is to be carried out in the protected area of substation of charged (Energized) site of CSPTCL and the work will be carried out abide by the following safety rules & regulation as communicated by EE(EHT-C) Dn.CSPTCL Bhilai. The loading, transportation, dragging / shifting, unloading of transformer and placement on plinth will be carried out very carefully and in a safe manner by arranging proper instrument, T&P, trailer, sleepers, wire rope, chain pulley block, sleepers etc. All the required T&P for loading, unloading, dragging and transportation for transformer work will be arranged by the

transporter. All the required expenditure towards arrangement of T&P and labour charges etc for the work will be arranged by the transporter / contractor.

7. The contractor should have necessary vehicle for transportation of heavy goods. In support, the copies of vehicle registration should be submitted with T/c bid.
8. The contractor will have to execute an agreement with CSPTCL within 7 (Seven) days from the date of issue of order, on non judicial stamp paper worth Rs. 300/- with a revenue stamp Rs.1/- affixed thereon, both the cost borne by the contractor failing which, the contract may be cancelled.
9. The successful bidder will be required to deposit 10% amount of the contract price as security deposit. An amount equal to that of 10% of the total value of the order initially placed, in the form of FDR pledged in favour of Manager RAO-HQ, CSPTCL, Raipur payable at Raipur valid up to scheduled completion date plus eight months.

**OR**

The contractor shall furnish a bank guarantee from a nationalized / scheduled bank for an amount of 10% (ten percent) of the value of the order as a contract security. This bank guarantee shall be submitted within 7 days from the date of issue of order and shall be kept valid for a period exceeding the scheduled completion date by two months with claim period of further six months. In the event of extension of completion date, the validity of the bank guarantee shall be suitably extended on stamp paper worth Rs. 250/- or as per the prevailing legal requirements / any other amount as per the C.G. State Stamp Duty Act in the prescribed form of CSPTCL..

10. The security deposit will be released after completion of the work satisfactorily & performance of the work certified by the concerned EE. No interest shall be paid by CSPTCL on security deposit. In case of non-fulfillment of contractual obligations by the contractor; the security deposit shall be forfeited. The desired document on this behalf i.e. Insurance certificate, license, EPF cases, payment to laboures on Govt. / Collector rate etc. should be furnished to concern OIC of the work.
11. **TAXES & DUTIES ETC:**
  - (i) **Goods and service tax (GST):-** Rates quoted and accepted for all items of "Price Bid" are exclusive of GST. As per Circular No. 1280 dtd 22.07.2017, GST on Goods Transport service is to be paid by CSPTCL to GST department.
  - (ii) **Payment of other taxes/duties/levies/charges which are not described above:-** The bidder should be aware of the various taxes, duties, levies imposed by the Central Government, State Government / local bodies applicable in the present contract as on the date of TC bid opening. Further, in the price bid, it should be specifically stated regarding each tax / duty whether it is inclusive or exclusive. However, if there is no specific mention of any tax/duties/levies as exclusive in the price bid, it will be presumed to be inclusive if it is applicable as on the date of TC bid opening and will not be

paid extra. But if any new tax/ duty/ levy is imposed either by central Government or by Stat Govt. / local authorities after the date of opening of T.C. Bid, the same shall be payable by CSPTCL extra within stipulated completion period on production of documentary evidence. However, tax due to increase of Turnover or withdrawal of tax exemption earlier available to the vendor etc. will not be reimbursed.

- (iii) **Income Tax:** - Income Tax will be deducted at source as per rules enforced.
12. The work will be carried out by observing all the rules and regulations regarding safety and any type of accident which if takes places would be the contractor's responsibility. The contractor shall be responsible for payment of all compensation as applicable from time to time to their workmen engaged on the work in the event of any accident. The necessary insurance cover for engaged person should be submitted by the contractor to the concern OIC i.e. EE, EHT Const. Dn. CSPTCL, Bhilai before commencement of work.
  13. The contractor shall be responsible for payment of all necessary fees towards fitness of truck/trailer, road tax, insurance of vehicle, wages of drivers & cleaners etc.
  14. The work included in this tender will have to be completed within 15 days by the contractor after handing over of the transformer and its accessories.
  15. The quantity and distance are provisional & may vary during actual execution of the work. However, the payment will be made as per job and actual execution of the work.
  16. The payment will be done through NEFT/RTGS/account payee Cheque only by the Regional Accounts Officer, CSPTCL Raipur within thirty days from the date of receipt of bill after completion of the work. After completion of the work, the contractor shall submit its bill within three months from its completion positively. In case payment is more than Rs.75,000/- the same will be done by the Manager (Bills) O/o ED (F&A), CSPTCL, Raipur. **Please enclose the account details along with a cancelled cheque.**
  17. The OIC of the work will be EE, EHT Const. Dn. CSPTCL, Bhilai. The work will have to be completed under supervision/ instruction of OIC or his authorized representative.
  18. If the contractor fails to start the work or to complete the work as specified in the scope of work order, the ED (C&LM) CSPTCL, Raipur reserves the right to get the unfinished work completed through any other agency at contractor's risk & cost.
  19. **CONTRACTORS DEFAULT LIABILITY**  
The CSPTCL may upon written notice of default to the contractor terminate the contract in circumstances detailed here under:-

(I) If, in the judgement of CSPTCL, the contractor fails to

(i) Complete the contractual formalities within the time specified in the contract agreement or within the period for which extension has been granted by CSPTCL to the contractor.

And/or

(ii) Comply with any of the provisions of this contract.

In such case (s) CSPTCL under the provisions of this contract shall take one or more of the following penal actions:-

(a) Terminate the contract.

(b) Forfeiture of EMD and/or Security deposit, if available.

(c) Debar the firm for future business with CSPTCL for a period of two years from the date of issue of letter to this effect.

(d) This debarring may be applicable in respect of other Chhattisgarh State Power Companies also as may be decided by their management.

**(II)** In case the contractor fails to commence the work within the reasonable period as decided by CSPTCL or fails to complete the works within the contractual completion period or the progress is not commensurate with the time period provided for completion of entire substation or within a period for which extension has been granted by CSPTCL, one or more of following penal actions may be taken by CSPTCL against the contractor.

(a) Terminate the contract.

(b) Forfeiture of security deposit, if available.

(c) Debar the firm for future business with CSPTCL for a period of two years from the date of issue of letter to this effect.

(d) This debarring may be applicable in respect of other Chhattisgarh State Power Companies also as may be decided by their management.

(e) The payment of pending RA bills of the instant contract shall be withheld.

(f) The payment of pending RA bills of the other running contracts shall also be withheld.

In case the work included in the tender is not completed in accordance to relevant clause of the tender “completion of work” and CSPTCL does not terminate the contract, the contractor shall continue to execute the work, in which case he shall liable to CSPTCL for deduction of liquidated damages for delay as per relevant clause of this contract until the project is completed.

20. The hire charges @ 2% per month or part thereof for issuing T&P etc. will be imposed on the basis of the cost of material / T&P including store incidental charges plus supervision charges in case of T&P is provided by the CSPTCL.
21. If the completion of work is delayed due to reason beyond the control of the contractor such as strikes, lockouts, fire accident, delay in approval of drawings, force Majeure conditions etc, then the contractor shall request to the CSPTCL in writing of his claim for an extension of time without delay. The CSPTCL on receipt

of such request may agree to extend the contract date of the work as may be reasonable but without prejudice to other terms and conditions of the contract

22. In case of delay in execution of the work, penalty @ ½% per week or part thereof subject to maximum of 5% of the total value of the order will be imposed for the balance work to be completed.
23. In the event of contractor committing a breach on any of the terms & condition laid down in the contract at any time for performance in their duties, the CSPTCL may forfeit security deposit and terminate the agreement by giving notice in writing in this behalf. Any dispute arising out of this contract, the ED (C&LM) CSPTCL, Raipur whose decision in the matter shall be final and binding on contractor.
24. The contractor shall entirely responsible for the proper handling of the transformer and its accessories during execution of work against the tender. Any loss/damage to the transformer and its accessories during execution of the work, shall be to the account of contractor and its cost will have to be borne by the contractor.
25. CSPTCL will not be responsible in respect of any accident loss or damage to the vehicle or liability directly or indirectly, remotely occurred or caused, sustained or incurred in the event of death of persons(s) employed by the contractor during the transportation, loading, unloading, counting or staking of materials.
26. As per the statutory obligation under PF Act. As amended, the contractor will have to furnish full particulars of PF / EPF / EDCEL contribution in respect of employees engaged.
27. All suits / litigation for proceeding relating to any dispute of claim arising out of the course of performance of the contract shall be made only in the competent court / tribunal / Law at Raipur.
28. The valid license from competent authority should be submitted by the contractor before commencement of work.
29. The payment of labour should be done / paid as per Govt./ Collector rate before CSPTCL representative and concerned division should ensure compliance of CSPTCL circular/rule.
30. The labour engaged by the contractor should be insured under the Workmen Compensation Act by the contractor during the entire period of contract including extended time, if any. The contractor has to arrange all safety appliances such as tools, hand gloves, shoes etc to their labour & safety should be followed strictly.
31. The EPF rule should be followed strictly and certificate of declaration, deduction of EPF of labour engaged & deposit of EPF etc. be submitted.
32. The above work has to be carried out in the specified location, as per the directives issued by the EE, EHT Const. Dn. CSPTCL, Bhilai.

33. Extension order maximum to 50 % of the total quantity within 6 month from the date of order may be placed on same rates, terms & conditions of the original order.
34. Rules and regulation should strictly be followed by the contractor and their persons engaged on the work.
35. The ED (C&LM) CSPTCL, Raipur reserves the rights to amend or cancel the tender / offers at any stage, without assigning any reason what so ever.
