
Tender documents (tender form, terms & conditions etc.) can be purchased on payment of **Rs 560/- (Rs 500/- + Rs 60/- GST) (Rs Five hundred sixty)** only in Shape of DD/ PO (non refundable) payable at Raipur, in favour of **Manager (RAO-HQ), CSPTCL, Raipur** from the office of the under-signed on or before **26/07/21.....up to 15.30 Hrs.** Postal charges worth Rs 200/- (Rs Two hundred) only should also be sent in advance by PO/ DD, by those tenderer who desire to obtain the tender documents by post. The request to send the tender documents through post may reach this office well before 10 days from the date of submission of tender documents.

The Participating vendor should be registered vendor in T&D wing of power companies of Chhattisgarh State.

The bidder whose material has not found up to the mark in previous order of power companies of CG State shall not be eligible in instant tender.

The tender in the prescribed form with Earnest Money of **Rs 2,500/- (Rs Two thousand five hundred)** only, in the form of Demand Draft favoring the **Manager (RAO-HQ), CSPTCL, Raipur** shall be **accepted up to 15.00 Hrs** on or before dated **27/07/21** and will be **opened on the same day at 15.30 Hrs** before the tenderer wish to be present. In case a holiday is declared by the Govt. on the schedule date, the last date for submission and opening of tender will automatically be shifted on the next working day. No offer will be accepted without Earnest Money and will be rejected. The EMD submitted by un-successful bidders shall be returned to them after finalization of the tender whereas the EMD in respect of L-1 bidder after furnishing the required Security Deposit. The Earnest Money in any other form will not be acceptable.
