

01.PQR:-

- (i) The bidder should be having experience of similar specialized work of RTU Commissioning, and one recent P.O. issued by CSPCL has to be provided for satisfactory evidence of performance.
- (ii) The bidder should be registered in CSPCL.

02. Sealed tenders/quotations are invited by the Office of Chief Engineer (C & TM) Chhattisgarh State Power Transmission Co. Ltd. Bhilai 490021 (C.G) for the contract award for **job work of dismantling of existing RTU at Bishrampur (Chemtrol-Make), customization of retrofitted RTU at Bhilai Communication lab, transporting & installation at Bishrampur, necessary cabling/wiring work, programming of MFT's and RTUs, pre-commissioning testing of this retrofit panel, commissioning and data validation at SLDC and transporting dismantled Chemtrol make RTU to Communication lab at Bhilai.**

Tender must reach the Office of Chief Engineer(C&TM) Chhattisgarh State Power Transmission Co. Ltd. Bhilai 490021(C.G) by 31.10.2020, 15:00 Hrs. Tenders received after the stipulated time/date will not be considered. 3. The tender shall be submitted in 3 parts.

Tender box shall be sealed at 03:00 pm and in no case tender shall be allowed to be dropped **after 03:00 pm**. The Tenders will be opened on same day 31.10.2020 at 15:30 Hrs.

05. VALIDITY:- Full descriptive particulars and complete specification should accompany the tender. Offers should be kept open for acceptance for at least three months(90 days) from the date of opening. However, due to circumstances beyond control, the bidders will be allowed to extend validity but they shall not be permitted to revise their rates, offer any rebate or concession while extending the validity which may materially result in any reduction/increase in the computed price of their original offer.

06. The bidders would abide by the terms and conditions and specification as given in tender document and in the attached schedule & no condition or stipulation contrary to our condition shall be applicable.

07. The Trans Company reserves the right:-

(i) To cancel any or all filled tenders or to accept any filled tender considered advantageous to the Trans Co.

(ii) To split/increase/decrease the quantities of material/works against the tender. No reason will be assigned by the Trans Co. for these and will be binding on the bidders.

08. In case of correction done in the tender, the bidders should initial the same otherwise the tenders may not be considered.

09. Telegraphic/email offers will not be considered.

10. All the bidders shall essentially indicate the break up of prices as shown in the tender form. In case any of the charges are not included in the quoted price, the same shall be clearly shown as "Extra" indicating specifically the rate/scale of such charges.

11. Please note that the bidders who did not accept terms and conditions stipulated in this tender specification their offers are liable to be out rightly rejected without assigning any reason whatsoever.

12. It is the responsibility of the bidder to make sure that all the documents required as per tender are submitted on or before the date of bid submission.

13. Earnest Money :- Each bidders should submit an earnest money deposit of Rs. 2500/- (Rs. Two Thousand five Hundred only) prior to submission of quotation in a separate envelope. The tenders not accompanied with earnest money will summarily be rejected.

14. FORM OF EARNEST MONEY DEPOSIT:- The earnest money deposit can be furnished :

15. FORFEITURE OF EARNEST MONEY DEPOSIT :-

It should be clearly understood that in the event of bidders failing to accept and execute the telegraphic and detailed orders, if it is placed within the validity period of the offer, the full amount of earnest money will be forfeited and Trans Company decision in this respect will be final and binding on the bidders.

16. The requirements may vary as per the site conditions. The Contractor has to complete the work accordingly. The payment shall be made as per the actual work done on prorata basis. The Contractor shall be allowed to work subject to availability of consent of the OIC. If consent could not be arranged due to unfavourable system conditions, the job completion period shall be amended accordingly.

17. The rates for job are to be quoted inclusive of cost of materials, supply etc of which is in the scope of firm.

18. PRICE :- The prices quoted should be FIRM along with clear bifurcation of all taxes and duties.

19. SCOPE OF WORK: The retrofitted RTU Peripherals (Rack, CPU Card, Analog and digital card & PSU Card should be well configured, input source 48 V DC, along with licensed software programming & finally transfer a receive generation data smoothly from Bishrampur to SLDC Raipur through the retrofitted RTU & finally display at SLDC end as per their need.

The subjected work involves the following site activities -

(i) Customization of retrofitted RTU at Bhilai Communication lab

(ii) Transporting & installation at Bishrampur,.

(iii) Necessary cabling/wiring work.

20. OTHER TERMS & CONDITIONS OF COMPANY :-

- (i) The firm shall compulsory provide personal protective equipments to his employees and in the event of his not providing the same by the data specified in the contract, it may be provided by CSPTCL at firm's cost and risk, and the cost will be recovered from his bills.
- (ii) The firm has to depute their Engineer/Representative for complete supervision throughout the work.
- (iii) All the safety rules & precautions should be strictly followed by the firm. In case of any accident happened due to negligence of safety, the firm shall be held responsible legally as well as financially.
- (iv) All other T&P, Testing equipment, consumable, spares etc. required for the subject work shall be arranged by the firm.
- (v) Complete report of Retrofitting & Commissioning of above system shall be prepared by the firm & should be handed over in two copies to Engineer-in-charge just after completion of the job.
- (vi) All the standard CSPTCL terms & conditions shall be applicable .
- (vii) Firm shall follow all the effective Govt. rules regarding wages, safety and submit the copy of labour license, agreement bond etc. before starting the work, if applicable.
- (viii) The firm will provide all necessary safety appliances to the labour and ensure compliance of safety rules, P.F. Rules, labour laws and directives of Director Industrial Health & Safety/Chief Electrical Inspector, Govt. of Chhattisgarh.
- (ix) In case of any penalty imposed by any of the Government authorities on the CSPTCL or any of its officers due to unsafe working conditions of the firm and/or any accident taking place during the course of work under the contract, it shall be paid by the contracting firm.
- (x) Complete installation, Testing after Commissioning shall be carried out by the firm only.
- (xi) All necessary tools, tackles, laptop for programming, connecting leads & technical/non-technical man power have to be arranged by the firm only with necessary factory act formalities.
- (xii) All photocopy documents must be self attested by the firm.
- (xiii) Free electricity above works will be arranged by CSPTCL free of cost.

21. PERFORMANCE GUARANTEE / DEFECTIVE SUPPLIES :- If during the course of 12 months from the date of completion of work, any defect is observed in workmanship or develops defect in service, the same will be replaced by the Contractor on free of all charges.

22. SECURITY DEPOSIT :- The Contractor will have to deposit 10% amount of the total contract value as SD. SD may be deducted from contractor bills if the contractor requests for the same. No interest shall be paid by CSPTCL on security deposit. In case of non-fulfilment of contractual obligations by the contractor, the security deposit shall be forfeited, SD can be deposited in the form of DD/FDR in favour of (RAO) CSPTCL, Raipur.

23. WORK COMPLETION PERIOD :- The work shall be completed within 30 days from the date of handing over of the site.

24. GUARANTEE: - The works should cover the guarantee for the period of 12 months against the workmanship. If work is found not satisfactory, accordingly recovery will be done from the contractor and job will be assigned to the other firm on contractors cost.

25. PAYMENT: - 100% payment shall be made by RAO, CSPTCL, Bilaspur within 30 days after completion of work & issue of satisfactory work completion certificate by EE(C&TM)Dn.Korba within a month. No interest shall be payable in case of delay in payment.

26. INCOME TAX DEDUCTION: - Deduction towards income tax will be made from the contractor bill as per rules in force.

27. PENALTY: - If the contractor fails to complete the order work within the specified time schedule, the penalty will be levied @ 0.5% per week or part thereof upto a maximum of 10% on the value of un completed portion of the work ordered on the contractor.

28. OFFICER INCHARGE: - The Executive Engineer (Commn. & Tele.) Dn. CSPTCL Korba will be the OIC.

29. GST & TAXES: - The firm/bidders should clearly indicate the applicable rate of GST with HSN Code. and any other taxes in force.

30.If any accident occurs during the course of working full liabilities lies on the Contractor and no compensation will be admissible by the Trans Co. The work is to be done in the supervision of the representative of the respective substation incharge of Trans Co. only.

31.Any damage or losses occurs to the trans Co. property during the work shall be recovered from the contractor bill.

32.**DISPUTE:** -Any dispute arising out of contract shall be subject to the jurisdiction of court at Durg.
