(d) The Bidder should have ESIC registration certificate.

(e) The Bidder should have executed at least single order of similar nature valuing not less than Rs. 1.86 lakhs during last three years i.e. year, 2017-18 and 2018-19,2019-20.

(f) The firm should have minimum Average Annual Turn over of Rs. 9.28 lakhs for the last three

years i.e. year, 2017-18 and 2018-19,2019-20.

#### **DURATION OF CONTRACT:-**4.
