1. PQR:-

- (i) The bidder should submit valid 'A' Class electrical contractor license issued by competent authority.
- (ii) The bidder should be registered in CSPCL.

- 2.** Tender must reach the Office of Chief Engineer(C&TM) Chhattisgarh State Power Transmission Co. Ltd. Bhilai 490021(C.G) by 05.01.2021, 15:00 Hrs. Tenders received after the stipulated time/date will not be considered. Covers should invariably be super scribed with "Tender for **Job work for providing and laying of 100 sq m. - 3.** The tender shall be submitted in 3 parts.

a. First envelope shall contain DD for EMD amount (Rs. 5000/-) in favour of RAO, CSPTCL, Raipur payable at Raipur ,the photo copy of M.R. of Rs. 560/- should also be enclosed in this envelope. Tender No., Due date & EMD should clearly be written on this envelope.

If the tender form is downloaded, then DD of Rs 590/- has to enclosed in a separate envelope along with EMD (5000/-). If the Earnest Money is not deposited, the tender will be rejected.

b. Second envelope shall contain the tender duly accepting the terms and conditions (Tender No., due date should be clearly written on this envelope.) Proforma for terms & conditions & other details shall be enclosed in this envelope.

c. Third envelope will contain the price Bid. (Tender No. Due date & Price bid should be clearly written on this envelope). All the three envelopes shall be enclosed in big sealed envelope Superscripting the tender no. & due date.

- 4.** When Tenders are delivered by special messenger by the firm , it should be dropped in the " Tender Box" kept in the office of Chief Engineer (C&TM) CSPTCL, Bhilai at any working day on or before the due date. No grant receipt for the delivered tender will be provided in any case. The duly filled tender should be dropped before or **upto 03:00 pm** on due date 05.01.2021. Tender box shall be sealed at 03:00 pm and in no case tender shall be allowed to be dropped **after 03:00 pm.**



- 5. VALIDITY:** - Full descriptive particulars and complete specification should accompany the tender. Offers should be kept open for acceptance for at least three months from the date of opening. However, due to circumstances beyond control, the bidders will be allowed to extend validity but they shall not be permitted to revise their rates, offer any rebate or concession while extending the validity which may materially result in any reduction/increase in the computed price of their original offer.

6. The bidders would be bound by the terms and conditions and specification as given in tender document and in the attached schedule & no condition or stipulation contrary to our condition shall be applicable.
7. CSPTCL reserves the right:-
 - (i) To reject any or all tenders or to accept any tender considered advantageous to the Trans Co.
 - (ii) To split the quantities of material/ works against the tender no reason will be assigned by the Trans. Co. for these and will be binding on the bidders.
8. In case of correction done in the tender, the bidders should initial the same otherwise the tenders may not be considered.
9. Postal/Telegraphic offers/email offers will not be considered.
10. All the bidders shall essentially indicate the break up of prices as shown in the tender form. In case any of the charges are not included in the quoted price, the same shall be clearly shown as "Extra" indicating specifically the rate/scale of such charges.
11. Please note that the bidders who do not accept terms and conditions stipulated in this tender specification their offers are liable to be out rightly rejected without assigning any reason whatsoever.
12. **EARNEST MONEY**: - Each bidder should submit an earnest money deposit of Rs. 5000/- (Rupees five thousand only) along with submission of quotation in a separate envelope. The tenders not accompanied with earnest money will summarily be rejected.
13. **FORM OF EARNEST MONEY DEPOSIT**: - The earnest money deposit can be furnished: By Demand Draft on a scheduled bank payable to the (RAO), CSPTCL, Raipur.
14. **FORFEITURE OF EARNEST MONEY DEPOSIT**: - It should be clearly understood that in the event of bidders failing to accept and execute the telegraphic and detailed orders, if it is placed within the validity period of the offer, the full amount of earnest money will be forfeited and Trans Company decision in this respect will be final and binding on the bidders.
15. The requirements may vary as per the site conditions. The Contractor has to complete the work accordingly. The payment shall be made as per the actual works done on prorata basis. The contractor shall be allowed to work subject to availability of consent of the OIC. If consent could not be arranged due to unfavorable system conditions, the job completion period shall be amended accordingly.
16. The Rates for job work are to be quoted inclusive of cost of materials, supply of materials, freight , manpower etc supply of which is in the scope of firm.
17. **PRICE**:-The prices quoted should be FIRM along with clear bifurcation of all taxes and duties.

18. **PERFORMANCE GUARANTEE / DEFECTIVE SUPPLIES**:- If during the course of 12 months from the date of completion of work, any of the goods is found to be defective in materials or workmanship or develops defect in service, the same will be replaced by the Contractor on free of all charges.
19. **SECURITY DEPOSIT**:- The contractor will have to deposit 10% amount of the total contract value as SD. SD may be deducted from contractor bills if the contractor requests for the same. No interest shall be paid by CSPTCL on security deposit. In case of non- fulfillment of contractual obligations by the contractor, the security deposit shall be forfeited. SD can be deposited in the form of DD/FDR in favour of (RAO) CSPTCL Raipur.
20. **WORK COMPLETION PERIOD**:- The works shall be completed within 45 days from the date of handing over of site.
21. **GUARANTEE**:-The works should cover the guarantee for the period of 12 months against the workmanship. If work is found not satisfactory, accordingly recovery will be done from the contractor and job will be assigned to the other firm on contractors cost.
22. **PAYMENT**: - 100% payment shall be made within 30 days by RAO, CSPTCL, Bilaspur, after completion of work & bill passing & issue of satisfactory work completion certificate by concerned EE within a month. No interest shall be payable in case of delay in payment.
23. **INCOME TAX DEDUCTION**:- Deduction towards income tax or any other taxes will be made from the contractor bill as per rules in force.
23. **PENALTY**: - If the contractor fails to complete the ordered work within the specified time schedule, the penalty will be levied @0.5% per week or part thereof up to a maximum of 10% on the value of un completed portion of the work ordered on the Contractor.
24. **INCREASE/DECREASE IN QUANTITY**:-CSPTCL reserves the right to increase/ decrease the quantity of works up to 50%.
25. **OFFICER INCHARGE**:- The Executive Engineer (Commn. & Tele.) Dn. CSPTCL, Bilaspur will be the OIC for work.
26. **SUBMISSION OF BILLS**: - All the bills shall be submitted in Triplicate to the Executive Engineer (Commn. & Tele.) Dn. CSPTCL Bilaspur.
27. **GST & Taxes**:- The firm/bidders should clearly indicate the applicable rate of GST item wise. And any other taxes in force.
28. If any accident occurs during the course of working full liabilities lies on the Contractor and no compensation will be admissible by the Trans Co. The work is to be done in the supervision of the representative of the respective substation in charge of Trans Co. only.
29. Any damage or losses occurs to the trans. Co. property during the work shall be recovered from the contractors bill.
30. The shut down, if necessary, will be arranged by the Engineer In- charge, at his convenience.

- 31. FORCE MAJEURE:** The contractor shall not be liable for any penalty /delay for failure for reasons of FORCE MAJEURE such as acts of God act of Public Enemy, act of Govt., cyclones ,fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes provided that the contractor shall within 10 days from the beginning of such delay notify CSPTCL in writing. After verification of notice, CSPTCL will notify of any extensions as per facts justify.
- 32. DISPUTE:** - Any dispute arising out of contract shall be subject to the jurisdiction of court at Durg.
- 33. AGREEMENT:-** The contractor will have to execute an agreement on non- judicial stamp paper worth Rs 250/- (Rs Two hundred fifty) only for which cost will have to be borne by the contractor.
- 34.** The agreement should be executed within 15 days from date of issue of work order.
- 35.** The bidder should initial with co. seal on all the pages of tender documents.
