**GENERAL TERMS & CONDITIONS OF TENDER SPECIFICATION.**

**01. Scope of work:-**

The Subject tender specification covers the **Job work replacement of 04 nos. 132 KV Isolator set & 02 nos. 33 KV Isolator set of 132 KV Baramkela feeder, 132 KV Kondatarai feeder & 33 KV Sarangarh-II feeder at 132 KV S/s CSPTCL, Raigarh under EE (S/s) Dn., CSPTCL, Raigarh.** The tenderers have to go through over technical requirements carefully and have to furnish all information as required for best execution of the work. The description of work is given here under:-

**02. Pre.Bid Qualifying Requirements:-**

The Tenderer shall comply the following requirements and should submit document in support along with the commercial bid:-

- The contractor shall have to submit self-certified copies of 'A' class valid Electrical License issued by Chief Electrical Inspector, CG Anugyapan Mandal Raipur.
- The bidder should be manufacturer or authorized distributor of manufacturing company or registered supplier in CSPTCL.
- The Bidder should have GST Registration no.
- The firm should have work experience on the subjected work supporting documents is to be enclosed with tender.
- The bidder should have experience of carrying out EHV Sub-station works in past. Order copies in support of this may be furnished with the bid.
- The Bidder should have executed at least single order for supply of materials for EHV line and S/s in CSPTCL or any of Govt. / Semi Govt./ Public sector/Reputed Private Sector/ Power utilities.
- Vender Registration, labour license and Registration in B&C& GST with tender documents.
- The contractor should be registered at least under category "C" for EHT & other tower line and construction work as well as EHT S/S works.
- The contractor shall have to submit self certified copy of GST, Pan card etc.

The above documentary evidence shall have to submit alongwith tender document (technical & commercial bids) in mandatory.

**03. Procedure for purchase of tender form:-**

Tender form/terms and conditions etc. can be purchased on payment of ₹ 224.00 (₹ Two Hundred Twenty four) only including GST@12% only in the shape of DD (Non refundable) in favour of RAO CSPTCL Bilaspur from the office of the SE (S/S-O&M) Circle, CSPTCL Bilaspur on or before 27/01/2021, up to 17.30 Hrs.

Tender forms along with relevant documents shall be issued to all prospective bidders who deposit appropriate tender fee. The eligibility criteria, etc shall be verified at the time of evaluation of tenders. The bids of those bidders who qualify the criteria of opening the bids, shall be opened only and the bids of disqualified bidders shall not be opened. Only one offer from one firm will be accepted. If more than one offer is found, CSPTCL will have right to reject any or all offer (s) without assigning any reason and EMD may be forfeited.

The tenderers must fill up complete tender form and should submit duly signed all pages by the firm's competent person with rubber seal of the firm. The documents should be free from over writing. if there is any overwriting/cutting that should be attested with seal and signature by the contractor, otherwise the same offer will be rejected. Any tender not bearing the signature in all the documents accompanying the tender shall be liable for rejection. The submission of tender by the tenderers implies that they have read and accepted the instructions, the terms and conditions of the contract etc. and have made them self aware of the scope of work to be done and local conditions/other facts bearing on the execution of the work.

**04. Earnest Money Deposit :-**

The contractor shall be accompanied by earnest money for ₹ 500.00 (₹ Five Hundred) only in the form of DD/Bankers Cheque in favour of RAO CSPTCL Bilaspur against instant tender. The offer without EMD shall not be considered and will be rejected. No interest shall be paid on EMD. In case of unsuccessful tenderer, the Earnest Money will be refunded after finalization of the tender however, the EMD of successful bidder will be refunded only after furnishing performance security and its acceptance.

**05. Procedure for Three part bidding :-**

The sealed tender are to be on three parts basis,

- (a) 1<sup>st</sup> envelope containing the EMD clearly super – scribed “EMD” on top,
- (b) 2<sup>nd</sup> envelope contain Technical and Commercial Bid should the tender documents clearly super- scribed “Technical–BID” on top and
- (c) 3<sup>rd</sup> envelope should contain the price bid clearly super- scribed “PRICE –BID” on top.

All the 03 envelopes shall be kept in one large sealed envelope, address to the SE (S/s-O&M) Circle, CSPTCL Bilaspur with name of work, NIT no.& date with due date, amount and mode of EMD, name of tenderer and dropped into tender box kept in chamber of SE (S/S-O&M) Circle, CSPTCL, BILASPUR up to 15.00 hrs. only on due date 28/01/2021. The tender box will be sealed at 15.00 hrs and after 15.00 hrs. no any offer will be accepted.

The tender will be open on the same day at 15.30 hrs. in the Chamber of SE (S/S-O&M) Circle, CSPTCL, Bilaspur, in the presence of participant bidders or their authorized representatives.

**06. Rates:-**

The quoted rates shall be firm during entire contractual period inclusive of all charges, excluding GST. The rates of GST shall have to mention on percent basis separately as per price bid. Rates shall be quoted both in words & figures in the price schedule enclosed. In case of deviation of rates in figures and words, rates quoted in words shall prevail. After acceptance of rates, the Company will not pay any extra charges for any reasons whatsoever, even in case the contractor later reports to have misjudged the conditions of the contract. The offer shall be valid for 90 days from the date of acceptance of tender.

**07. Precautions:-**

Job work replacement of 04 nos. 132 KV Isolator set & 02 nos. 33 KV Isolator set of 132 KV Baramkela feeder, 132 KV Kondatarai feeder & 33 KV Sarangarh-II feeder at 132 KV S/s CSPTCL, Raigarh under EE (S/s) Dn., CSPTCL, Raigarh has to carry out in premises of EHV S/s, hence the contractor will be fully responsible for observing all necessary safety precautions/rules.

**08. Security Deposit :-**

The Lowest bidder will have to deposit 10% of total value of material and services of the contract award as security deposit. The SD will have to be deposited in the form of DD/Bankers cheque in favour of Regional Accounts Officer, CSPTCL, Bilaspur in this office before taking over the site. The amount of SD may be deducted from contractor's bill. The S.D. may be also accepted in the shape of F.D.R. duly pledged in favour of R.A.O. CSPTCL, Bilaspur. The SD will be released after completion of guarantee period and performance certificate issued by concerned division.

**09. Contractor's liability for engaged worker :-**

The contractor shall have to registered his all the workmen engaged for execution of this work under B&C establishment in the O/o Labour Commissioner of the area where work is to be executed and copy of the same should be submitted to the concern Division or as per laws & rules of B&C. The labour engaged by the contractor should be insured under the workmen compensation act 1923 and amended time to time by the contractor during the entire period of contract. The contractors have to be registered under EPF/E.S.I. The payment of wages & fringe benefits should be done as per clause 22 of Nyuntam Vetan Adhinyam 1948 & Labour contract act's Clause 21 of Regulation- Abolition act 1970, and also declared by Govt./Dist. Collector as enforce during the execution of work.

**10. Officer-incharge of the work:-**

The Job work replacement of 04 nos. 132 KV Isolator set & 02 nos. 33 KV Isolator set of 132 KV Baramkela feeder, 132 KV Kondatarai feeder & 33 KV Sarangarh-II feeder at 132 KV S/s CSPTCL, Raigarh under EE (S/s) Dn., CSPTCL, Raigarh will have to be carried out in supervision of EE (S/s) Dn. CSPTCL, Raigarh or in his authorized representative.

**11. Payment:-**

100% payment shall be made within 30 days from the date of completion of the job work and submission of bill in quadruplicate in the O/o EE (S/s) Dn. CSPTCL, Raigarh by the firm. No interest shall be paid in case of delay in payment. However, the concerned EE (S/S) Dn. shall ensure strict compliance of the instructions contained in the circular No. DGM/HR-Trans/Pur/Circular/1875, dtd. 20.10.2011 for payment of the firm's bills. The payment shall be made by the Regional Accounts Officer, CSPTCL, Bilaspur.

**12. Other charges:-**

The CSPTCL will not pay any other charges in addition to job work for replacement of 04 nos. 132 KV Isolator set & 02 nos. 33 KV Isolator set of 132 KV Baramkela feeder, 132 KV Kondatarai feeder & 33 KV Sarangarh-II feeder at 132 KV S/s CSPTCL, Raigarh under EE (S/s) Dn., CSPTCL, Raigarh offered by the firm. Hence, before quoting the rates, the tenderer should ensure not to quote any other charges, except taxes.

**13. Income tax:-**

Income Tax at source as per Govt. rules will be deducted from the gross amount of bill for which TDS may be issued from accounts department on request as per rule.

**14. Goods & service tax:-**

Tenderer shall submit documentary evidence for Registration regarding Goods & Service Tax with appropriate authority. Payment of GST will be made as per rules enforce.

**15. Jurisdiction:-**

Any dispute or difference, arising out of or in connection with the detailed order shall be subject to exclusive jurisdiction of competent court of Bilaspur (CG) only.

**16. Work completion period:-**

The site will be handed over within 7 days after execution of agreement and the complete work shall have to be completed within 60 days from the date of handing over of the site.

**17. Force Majeure:-**

The force majeure condition/circumstances shall include strikes, slow down by labour, lock outs, war, fire accidents, earthquakes, floods, natural calamity, riots, damage to plant, stoppage at the works and un-availability of timely shutdowns or any other reasons whatsoever beyond reasonable control of the Firm/Contractor. In case of force majeure conditions, CSPTCL may consider request for time extension, if found valid.

**18. Penalty:-**

In case of delay in completion of work, penalty @ 0.5% per week or part thereof subject to a maximum of 10% on the cost of incomplete/delayed work shall be levied on the Firm/Contractor.

**19. Liquidated damages:-**

As the work is to be carried out in the protected area of CSPTCL, it should be ensured that there is no any damage to any of the already erected equipments/materials. If any damage/breakage is found to any of the equipments in the EHV Sub-Station during the course of work, the same shall be repaired/replaced by the Contractor/firm at his own cost.

**20. Safety Measure:-** The works are to be done in presence of CSPTCL's representative to avoid any undesirable incidence.

- a) Only trained and experienced person on relevant field/work may be deputed to carry out the work under direct supervision of firm's engineer and authorized person of sub- station.
- b) As the work is to be carried out in the 132/33 KV live sub-station switchyard, contractor shall be fully responsible for observing the safety rules and maintaining the required clearance (minimum 6 feet from the line/ equipment) while fixing the Isolator set.
- c) As this work is to be carried out in the protected area, it should be ensured that there is no damage to any of the erected equipment. If any breakage or damage is found to any Sub-station equipments during the course of above work, the same has to be attended /repaired by the contractor free of cost.
- d) If Shutdown needed during the course of execution of work, the shutdown shall be arranged by CSPTCL after receipt of information from contractor.

**21. Defective Work:-** Any defect noticed in the works/ materials within a period of 12 months and reported subsequently, then goods shall be replaced/ rectified on free of cost by you..

**22. Risk coverage:-**

As the work is to be carried out in the live switchyard area and protected area of CSPTCL, the firm should ensure observation of all safety rules and regulations. CSPTCL will not hold any responsibility for any accident. However, the firm/contractor should arrange insurance for the life of their service personnel at his own cost. The provisions of the Workmen's Compensation Act as per relevant clauses shall be applicable & binding on the Contractor/Firm.

**21. Agreement:-**

On award of contract, the firm/contractor has to enter into an agreement with CSPTCL within 7 days for faithful completion of the work on a non judicial stamp paper worth ₹. 250.00 (₹. Two hundred fifty) with dully affixed revenue stamp worth ₹ 1=00 only. The duty of the stamp paper is to be borne by the contractor.
