### GENERAL INSTRUCTIONS TO BIDDERS

The submission of a quotation by a bidder implies that all the instructions, terms and condition etc. have been read and the bidder is aware of and has accepted these conditions.

1. PQR:-  
The bidder should be registered in CSPCL.

02. Sealed tenders/quotations are invited by the Office of Chief Engineer (C & TM) Chhattisgarh State Power Transmission Co. Ltd. Bhilai 490021 (C.G) for **Supply of serial data terminal server & port splitter for data telemetry at 132 KV S/s Kuhera under EE(C&TM)Dn. Raipur.** as per the specifications. Tender must reach the Office of Chief Engineer (C&TM) Chhattisgarh State Power Transmission Co. Ltd. Bhilai 490021(C.G) by 28.01.2021, 15:00 Hrs. Tenders received after the stipulated time/date will not be considered. Covers should invariably be super scribed with Tender for **Supply of serial data terminal server & port splitter for data telemetry at 132 KV S/s Kuhera under EE(C&TM)Dn. Raipur, along with Earnest Money Deposit Rs. 3000/- (Rs.Three Thousand only) by Demand Draft payable in favour of the (RAO-CSPTCL), Chhattisgarh State Power Transmission Co. Ltd., Raipur.** The Tender will be opened on 28.01.2021 at 15:30Hrs.

03. The tender shall be submitted in 3 parts:-

- a. First envelope shall contain DD for EMD amount 3000/- in favour of RAO, CSPTCL, Raipur payable at Raipur ,the photo copy of M.R. of Rs. 560/- (if purchased & Rs. 590/- if downloaded) (Tender No., Due date & EMD should clearly be written on this envelope) should be enclosed in this envelope. If the Earnest Money is not deposited, the tender will be rejected.
- b. Second envelope shall contain the schedule 1 duly accepting the terms. (Tender No., due date should be clearly written on this envelope.) Proforma for terms & conditions & other details shall be enclosed in this envelope.
- c. Third envelope will contain the page No. 3 i.e. the price Bid. (Tender No. Due date & Price bid should be clearly written on this envelop). All the three envelopes shall be enclosed in big sealed envelope Superscripting the tender No. & due date.

04. No grant receipt for the delivered tender will be provided in any case. Receipt of tenders shall not be given in any case. The duly filled tender should be dropped on/before upto **03:00 pm** on due date of submission. Tender box shall be sealed at 03:00 pm and in no case tender shall be allowed to be dropped **after 03:00 pm. The Tenders will be opened on due date at 15.30 Hrs.**

05. **VALIDITY:-** Full descriptive particulars and complete specification should accompany the tender. Offers should be kept open for acceptance for at least three months (90 days) from the date of opening. However, due to circumstances beyond control, the bidders will be allowed to extend validity but they shall not be permitted to revise their rates, offer any rebate or concession while extending the validity which may materially result in any reduction/increase in the computed price of their original offer.

06. The bidders would abide by the terms and conditions and specification as given in tender document and in the attached schedule & no condition or stipulation contrary to our condition shall be applicable.
07. The Trans Company reserves the right:-
- (i) To reject any or all tenders or to accept any tender considered advantageous to the Trans Co.
  - (ii) To split the quantities of material, increase/decrease the quantities against the tender. No reason will be assigned by the Trans Co. for these and will be binding on the bidders.
08. In case of correction done in the tender, the bidders should initial the same otherwise the tenders may not be considered.
09. Telegraphic/Email offers will not be considered.
10. All the bidders shall essentially indicate the breakup of prices as shown in the tender form. In case any of the charges are not included in the quoted price, the same shall be clearly shown as "Extra" indicating specifically the rate/scale of such charges.
11. Please note that the bidders who did not accept terms and conditions stipulated in this tender specification their offers are liable to be outrightly rejected without assigning any reason whatsoever.
12. **Earnest Money**:-Each bidder should submit an earnest money deposit of Rs. 3000/- (Rupees Three Thousand Only) prior to submission of quotation in a separate envelope. The tenders not accompanied with earnest money will summarily be rejected. The Earnest Money will be refunded to un-successful Bidder within the reasonable time. The Earnest Money deposited by the successful Bidder will be released after the acceptance of security deposit, but shall be forfeited, if the contractor fails to execute the contract after intimation of the acceptance of his bid.
13. **FORM OF EARNEST MONEY DEPOSIT**:-The earnest money deposit can be furnished by Demand Draft on a scheduled bank payable to the (RAO), CSPTCL, Raipur.
14. **FORFEITURE OF EARNEST MONEY DEPOSIT**:-  
It should be clearly understood that in the event of bidders failing to accept and execute the telegraphic and detailed orders, if it is placed within the validity period of the offer, the full amount of earnest money will be forfeited and Trans Company decision in this respect will be final and binding on the bidders.
15. **FORCE MAJEURE**: The contractor shall not be liable for any penalty /delay for failure for reasons of FORCE MAJEURE such as acts of God. act of Public Enemy, act of Govt., cyclones ,fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes provided that the contractor shall within 10 days from the beginning of such delay notify CSPTCL in writing. After verification of notice, CSPTCL will notify of any extensions as per facts justify.
16. **PRICE**:-The prices quoted should be FIRM along with clear bifurcation of all taxes and duties.

**PERFORMANCE GUARANTEE / DEFECTIVE SUPPLIES** :- If during the course of 12 months from the date of completion of work, any of the goods is found to be defective in materials or as per manufacturer's warranty (whichever is higher), or develops defect in service, the same will be replaced by the Contractor on free of all charges.

18. **SECURITY DEPOSIT**:-The Contractor will have to deposit 10% amount of the total contract value as SD. SD may be deducted from contractor bills if the contractor requests for the same. No interest shall be paid by CSPTCL on security deposit. In case of non-fulfilment of contractual obligations by the contractor, the security deposit shall be forfeited; SD can be deposited in the form of DD/FDR in favour of (RAO) CSPTCL, Raipur.
19. **SUPPLY COMPLETION PERIOD**: - The supply shall be completed within 30 days from the date of order placed.
20. **PAYMENT**: - 100% payment shall be made within 30 days after supply of material to EE (Area Stores), Bhilai., by RAO, CSPTCL, Raipur .
21. **INCOME TAX DEDUCTION**: - Deduction towards income tax will be made from the contractor bill as per rules in force.
22. **PENALTY**: - If the contractor fails to complete the order within the specified time schedule, the penalty will be levied @ 0.5% per week or part thereof upto a maximum of 10% on the value of un completed portion of the supply ordered on the contractor.
23. **INCREASE/DECREASE IN QUANTITY**: - The Trans Co. reserves the right to increase/decrease the quantity of works upto 50%.
24. **CONSIGNEE** - The Executive Engineer, Area Stores. CSPTCL, Bhilai.
25. **GST & TAXES**: - The firm/bidders should clearly indicate the applicable rate of GST item wise. And any other taxes in force.
