Tender must reach the Office of Chief Engineer(C&TM) Chhattisgarh State Power Transmission Co. Ltd. Bhilai 490021(C.G) by 04.02.2021, 15:00 Hrs. Tenders received after the stipulated time/date will not be considered. Covers should invariably be super scribed with "Tender for job work of supply & fixing of 48 Nos. 36W/40W, LED Panel Lights in carrier room at various 220/132 KV EHV S/Stns. under Communication & Telemetry Division, CSPTCL, Raipur.

**03.** The tender shall be submitted in 3 parts.

**a.** First envelope shall contain DD for EMD amount (Rs. 3200/-) in favour of RAO, CSPTCL, Raipur payable at Raipur, the photo copy of M.R. of Rs. 560/-should also be enclosed in this envelope. Tender No., Due date & EMD should clearly be written on this envelope.

If the tender form is downloaded, then DD of Rs 590/- along with EMD (Rs. 3200/-) has to enclosed in a separate envelope along with EMD. If the Earnest Money is not deposited, the tender will be rejected.

- **b.** Second envelope shall contain the tender duly accepting the terms and conditions (Tender No., due date should be cleared written on this envelope.) Proforma for terms & conditions & other details shall be enclosed in this envelope.

- o5. VALIDITY: Full descriptive particulars and complete specification should accompany the tender. Offers should be kept open for acceptance for at least three months (90 days) from the date of opening. However, due to circumstances beyond control, the bidders will be asked to extend validity but they shall not be permitted to revise their rates, offer any rebate or concession while extending the validity which may materially result in any reduction/increase in the computed price of their original offer.

- O6. The bidders would abide by the terms and conditions and specification as given in tender document and in the attached schedule & no condition or stipulation contrary to our condition shall be applicable.
- 07. The CSPTCL reserves the right:-
  - (i) To cancel any or all filled tenders or to accept any filled tender considered advantageous to the CSPTCL whether it is lowest tender or not.
  - (ii) To split/increase/decrease the quantities of material/works against the tender .No reason will be assigned by the CSPTCL for these and will be binding on the bidders.
- **08.** In case of correction done in the tender, the bidders should initial the same otherwise the tenders may not be considered.
- 09. Telegraphic/email offers will not be considered.
- 10. All the bidders shall essentially indicate the breakup of prices as shown in the tender form. In case any of the charges are not included in the quoted price, the same shall be clearly shown as "Extra" indicating specifically the rate/scale of such charges.
- 11. Please note that the bidders who did not accept terms and conditions stipulated in this tender specification their offers are liable to be out rightly rejected without assigning any reason whatsoever.
- 12. <u>Earnest Money:</u>-Each bidders should submit an earnest money deposit of Rs.3200 /- (Rupees Three Thousand two hundred only) prior to submission of quotation in a separate envelope. The tenders not accompanied with earnest money will summarily be rejected.

#### 14. FORFEITURE OF EARNEST MONEY DEPOSIT:-

It should be clearly understood that in the event of bidders failing to accept and execute the telegraphic and detailed orders, if it is placed within the validity period of the offer, the full amount of earnest money will be forfeited and CSPTCL decision in this respect will be final and binding on the bidders.

- 15. The requirements may vary as per the site conditions. The Contractor has to complete the work accordingly. The payment shall be made as per the actual work done on prorata basis. The Contractor shall be allowed to work subject to availability of consent of the OIC. If consent could not be arranged due to unfavourable system conditions, the job completion period shall be amended accordingly.
- 16. The rates for job are to be quoted inclusive of cost of materials, supply etc of which is in the scope of firm.
- 17. PRICE:-The prices quoted should be FIRM along with clear bifurcation of all taxes and duties.
- 18. PERFORMANCE GUARANTEE / DEFECTIVE SUPPLIES:-If during the course of 12 months from the date of completion of work, any defect is observed in workmanship/material supply, or develops defect in service, the same will be replaced by the Contractor on free of all charges.
- 19. **SECURITY DEPOSIT:**-The Contractor will have to deposit 10% amount of the total contract value as SD. SD may be deducted from contractor bills if the security deposit. In case of non-fulfilment of contractual obligations by the form of DD/FDR in favour of (RAO) CSPTCL, Raipur.

**WORK COMPLETION PERIOD:** - The work shall be completed within 30 days from the date of handing over of the site.

21. GUARANTEE: -The supplied 36/40W LED Panel Light shall be

guaranteed for 12 months from the date of job completion.

PAYMENT: - 100% payment shall be made within 30 days after completion of work & issue of satisfactory work completion certificate by EE(C&TM) Dn.Raipur within a month. No interest shall be payable in case of delay in payment.

23. INCOME TAX DEDUCTION: - Deduction towards income tax and any other

taxes will be made from the contractor bill as per rules in force.

- **PENALTY:** If the contractor fails to complete the order work within the specified time schedule, the penalty will be levied @ 0.5% per week or part thereof upto a maximum of 10% on the value of un completed portion of the work ordered on the contractor.
- **25. INCREASE/DECREASE IN QUANTITY:** The CSPTCL reserves the right to increase/decrease the quantity of works upto 50%.
- **26.** OFFICER INCHARGE: The Executive Engineer (Commn. & Tele.) Dn. CSPTCL Raipur /Or his/her authorized representative.
- **27. GST & TAXES:** The firm/bidders should clearly indicate the applicable rate of GST with HSN Code. and any other taxes in force.
- 28. If any accident occurs during the course of working full liabilities lies on the Contractor and no compensation will be admissible by the CSPTCL The work is to be done in the supervision of the representative of the respective substation incharge of CSPTCL only.
- 29. Any damage or losses occurs to the CSPTCL property during the work shall be recovered from the contractor bill.
- **30. DISPUTE:** -Any dispute arising out of contract shall be subject to the jurisdiction of at Durg.
- **31. AGREEMENT:** The contractor will have to execute an agreement on non-judicial stamp paper worth Rs 250/- (Rs Two Hundred fifty) only for which cost will have to be borne by the contractor. The agreement should be executed within 15 days from date of issue of work order.
