1. PQR:-

- I. **The Participating vendor should be registered vendor in Power companies of Chhattisgarh State.**
- II. **The bidder whose material and work has not found up to the mark in previous order of power companies shall not be eligible in instant tender.**

Sealed tenders/quotations are invited by the Office of Chief Engineer (C & TM) Chattisgarh State Power Transmission Co. Ltd. Bhilai 490021 (C.G) for the contract award for the **Job work of providing and installation of 04 Nos. Air conditioners (1 nos. 2T & 3 Nos. 1.5 T, Split type, 3 star, Make: Daikin/ Voltas/ LG/ Bluestar or equivalent with accessories) in office building of CE (C&TM) CSPTCL, Bhilai**

Tender must reach the Office of Chief Engineer (C&TM) Chhattisgarh State Power Transmission Co. Ltd. Bhilai 490021(C.G) by 03.02.2021, 15:00 Hrs. Tenders received after the stipulated time/date will not be considered. Covers should invariably be super scribed "Tender for **Job work of providing and installation of 04 Nos. Air conditioners (1 nos. 2T & 3 Nos. 1.5 T, Split type, 3 star, Make: Daikin/ Voltas/ LG/ Bluestar or equivalent with accessories) in office building of CE (C&TM) CSPTCL, Bhilai.**, along with Earnest Money Deposit Rs. 3000/- (Rs. Three Thousand only) by Demand Draft payable in favour of the (RAO), Chhattisgarh State Power Transmission Co. Ltd., Raipur. The Tender will be opened on 03.02.2021 at 15:30 Hrs.

2. The tender shall be submitted in 3 parts.

- a. First envelope shall contain DD for EMD amount (**Rs. 3000.00**) in favour of RAO, CSPTCL, Raipur payable at Raipur & the photo copy of M.R. of Rs. 560/- for cost of tender form., should be enclosed in this envelope. Tender No., due date & EMD should clearly be written on this envelope. If the Earnest Money is not deposited, the tender will be rejected. If the tender form is downloaded, then DD of Rs 590/- has to enclosed in a separate envelope along with EMD (Rs. 3000.00). If the Earnest Money is not deposited, the tender will be rejected.

- b. Second envelope shall contain the tender duly accepting the terms. (Tender No., due date should be cleared written on this envelope.) Performa for terms & conditions & other details shall be enclosed in this envelope.
- c. Third envelope will contain the price Bid. (Tender No. Due date & Price bid should be clearly written on this envelope). All the three envelopes shall be enclosed in big sealed envelope Superscripting the tender no. & due date.

3. When Tenders are delivered by special messenger, it should be dropped in the "Tender Box" kept in the office of Chief Engineer (C&TM) CSPTCL, Bhilai at any working day. No receipt for the delivered tender will be provided in any case. In case, the tender is downloaded, it will be responsibility of bidder to drop/get dropped the tender in the tender box along with required documents and DD. Receipt of tenders shall not be given in any case. The duly filled tender should be dropped before or **upto 03:00 pm** on due date 03.02.2021 of submission. Tender box shall be sealed at 03:00 pm and in no case tender shall be allowed to be dropped **after 03:00 pm. The Tenders will be opened on same day 03.02.2021 at 15:30 Hrs.**

4. **VALIDITY:** - Full descriptive particulars and complete specification should accompany the tender. Make & specification of the goods should clearly be mentioned in the offer/ quotation otherwise the quotation / Offer will be liable to be rejected. Offers should be kept open for acceptance for at least three months from the date of opening. However, due to circumstances beyond control, the bidders will be allowed to extend validity but they shall not be permitted to revise their rates, offer any rebate or concession while extending the validity which may materially result in any reduction/increase in the computed price of their original offer.

5. **PRICE:** - The prices quoted should be FIRM along with clear bifurcation of all taxes and duties. While quoting prices, bidders should consider benefit of Input Tax Credit (ITC) available under GST Act-2017 and passing the same to CSPTCL.

6. **GSTIN:**-The rate of GST shall be mentioned separately as per GST Act 2017. The GSTIN shall invariably be mentioned on the quotation.

7. **Earnest Money**:- Each bidders should submit an earnest money deposit of Rs. 3000/- (Rupees Three Thousand Only) prior to submission of quotation in a separate envelope. The tenders not accompanied with earnest money will summarily be rejected.
8. **FORM OF EARNEST MONEY DEPOSIT**:- The earnest money deposit can be furnished in the following form: By Demand Draft on a scheduled bank payable to the (RAO), CSPTCL, Raipur.
9. **FORFEITURE OF EARNEST MONEY DEPOSIT**: - It should be clearly understood that in the event of bidders failing to accept and execute the telegraphic and detailed orders, the full amount of earnest money will be forfeited and Trans Company decision in this respect will be final.
10. **SECURITY DEPOSIT**: - The Contractor will have to deposit 10% amount of the total contract value as SD. SD may be deducted from contractor bills if the contractor requests for the same. No interest shall be paid by CSPTCL on security deposit. In case of non-fulfilment of contractual obligations by the contractor, the security deposit shall be forfeited; SD can be deposited in the form of DD/FDR in favour of (RAO) CSPTCL, Raipur.
11. **PAYMENT**: - 100% payment shall be made within 30 days after completion of work & issue of satisfactory work completion certificate by EE(C&TM) O/o CE(C&TM), Bhilai within a month. No interest shall be payable in case of delay in payment.
12. **INCOME TAX DEDUCTION**: - Deduction towards income tax will be made from the contractor bill as per rules in force.
13. **TRANSIT RISK**:-The transit risk shall be on firm/contractor's part. Any losses/ damage/ shortage etc. of goods should be made free of charges on reporting within 30 days from the date of receipt of materials/ & work completion.
14. **LEAFLETS**:- Leaflets & description literature giving full particulars & drawing of equipment, should accompany the quotation.
15. **GUARANTEE & FREE SERVICE**:-The material/ work should cover the guarantee for the period of 12 month against the manufacturing defects or as provided by the manufacturer whichever is higher. The date of guaranty shall be reckoned from the date of work completion. Brand name of the material should be genuine. **If found duplicate, the firm will be black listed and recovery will be done. Free servicing coupons, if any with the product should also be enclosed.**

If during the course of 12 months from the date of completion of work, any defect is observed in workmanship or develops defect in service, the same will be replaced by the Contractor on free of all charges. If work is found not satisfactory, accordingly recovery will be done from the contractor and job will be assigned to the other firm on contractors cost.
16. **CONSIGNEE AND NODAL OFFICER**:-The Executive Engineer O/o CE, (C&TM CSPTCL, Bhilai.
17. **COMPLETION PERIOD**:-The Completion period for execution of the work (providing & installation) shall be 45 days from the date of handing over of site. The requirements may vary as per the site conditions. The Contractor has to complete the work accordingly. The payment shall be made as per the actual work done on prorata basis. The Contractor shall be allowed to work subject to availability of consent of the OIC. If consent could not be arranged due to unfavourable system conditions, the job completion period shall be amended accordingly.
18. **PENALTY**: - If the contractor fails to complete the order work within the specified time schedule, the penalty will be levied @ 0.5% per week or part thereof upto a maximum of 10% on the value of un completed portion of the work ordered on the contractor.
19. The bidders would abide by the terms and conditions and specification as given in tender document and in the attached schedule & no condition or stipulation contrary to our condition shall be applicable. The Trans Company reserves the right:-
 - (i) To cancel any or all filled tenders or to accept any filled tender considered advantageous to the Trans Co. whether it is lowest tender or not.
 - (ii) To split/increase/decrease the quantities of material/works against the tender. No reason will be assigned by the Trans Co. for these and will be binding on the bidders.

- (iii) In case of correction done in the tender, the bidders should initial the same otherwise the tenders may not be considered.
 - (iv) Telegraphic offers will not be considered.
 - (v) All the bidders shall essentially indicate the break up of prices as shown in the tender form. In case any of the charges are not included in the quoted price, the same shall be clearly shown as "Extra" indicating specifically the rate/scale of such charges.
 - (vi) Please note that the bidders who did not accept terms and conditions stipulated in this tender specification their offers are liable to be out rightly rejected without assigning any reason whatsoever.
 - (vii) The rates for job are to be quoted inclusive of cost of materials, supply etc of which is in the scope of firm.
 - (viii) If any accident occurs during the course of working full liabilities lies on the Contractor and no compensation will be admissible by the Trans Co. All the safety measures should be taken care by the contractor.
 - (ix) Any damage or losses occurs to the trans Co. property during the work shall be recovered from the contractor bill.
- 20. FORCE MAJEURE:** The contractor shall not be liable for any penalty /delay for failure for reasons of FORCE MAJEURE such as acts of God act of Public Enemy, act of Govt., cyclones, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes provided that the contractor shall within 10 days from the beginning of such delay notify CSPTCL in writing. After verification of notice, CSPTCL will notify of any extensions as per facts justify.
- 21. DISPUTE:** -Any dispute arising out of contract shall be subject to the jurisdiction of court at Durg.
- 22. AGREEMENT:** - The contractor will have to execute an agreement on non-judicial stamp paper worth Rs 250/- (Rs Two Hundred fifty) only for which cost will have to be borne by the contractor. The agreement should be executed within 15 days from date of issue of work order.
- 23.** The bidder should intial with co. seal on all pages of tender documents.
