### Terms & conditions:-


1. The standard terms of payment are within 30 days from the date of submission of bill in five copies to EE (S/s) Dn., Bhilai after satisfactory completion of work.
2. The rates should be quoted on firms basis & taxes are to be mentioned separately (in words as well as figures).
3. In case of any major / minor accident, legal formalities/All statutory payable compensation etc. shall be born by contractor.
4. The work is to be carried out by observing all the rules and regulations of CSPTCL and safely precautions.
5. **Insurance of Consignment and Manpower** : - The insurance of transformer during loading, transportation and unloading will be done by Firm/ Contractor at his own cost.  
The labour engaged by the contractor should be insured under the Workmen Compensation Act all the Employees liability as per statutory provision shall be on the contractor during the entire period of the contract including extended time, if any.

6. The undersigned reserves the right to accept or reject the offer on behalf of CSPTCL and decision shall be final.
  7. The rate quoted should be excluding GST.
  8. **PENALTY:** In case of delay in work penalty will be imposed @ 0.5% per week or part thereof up to the maximum 10% of value of order.
  9. **SECURITY DEPOSIT :-** The successful contractor / bidders shall have to deposit security amount at the rate of 10% of the value of the contract ordered in the form of Bank Draft. In case the security deposit is in the form of F.D.R. the same should be duly pledged in favour of "The Manager (RAO-H.Q), CSPTCL, Danganiya, Raipur." The Security Deposit can also be deducted from contractor's bill. No interest shall be paid by CSPTCL on the security deposit. in case of non-fulfillment of contractual obligations by the contractor, the security deposit shall be forfeited.
  10. **COMPLETION PERIOD: -** The work will be commence & immediately after placing of order and the work should be done continuously and shall be completed within 05 days from the handing over of site.
  11. The contractor shall entirely responsible for the proper handling of the equipment and its accessories in the field. Any damage to the CSPTCL's materials during execution of the work / transportation from site to work site, the entire responsibility will be of the contractor, during any stage of work, its cost will have to be borne by the contractor and the cost of material will be deducted from Bill of contractor.
  12. The work will be done by the contractor as per the contract specification. Any defect noticed, should be rectified by the contractor free of cost to CSPTCL upon written notice, provided such defect are due to bad workmanship.
  13. The work is to be carried out in the protected / specific Sub-station site and the work will be carried out following the rules & regulation as communicated by EE (S/s) Dn., Bhilai.
  14. The work will be carried out by observing all the rules and regulations regarding safety and any type of accident if takes place would be the contractor's responsibility. The contractor shall be responsible for payment of all compensation as applicable from time to time to their workmen engaged for the work.
  15. The quantum of works is tentative and may be subjected to minor changes during execution of work depending upon site condition. However, the payment will be made on firm basis as per order value.
  16. The payment will be done through account payee cheque only by the Accounts Officer, CSPTCL Raipur within thirty days from the date of receipt of bill after completion of the work. In case payment is more than Rs. 2,50,000/- the same will be done by the Manager (Bill) O/o ED (F&A), CSPTCL, Raipur.
  17. The contractor should have experience of doing similar type of work viz. dismantling/ erection/Loading/Unloading/shifting & dragging/transportation of EHV class X-mer i.e. 400KV or 220KV or 132KV.
  18. The OIC of the work will be EE (S/s) Dn., Bhilai under whose supervision or his authorized representative, the work will have to be completed.
  19. If the contractor fails to start the work or to complete the work as specified in the scope of work order, the C.E. (S/s-O&M) CSPTCL, Raipur. Reserves the right to get the unfinished work completed through any other agency at risk and cost of the instant contractor.

20. Deduction towards Income Tax @ 2% (or as per revision issued by the Govt. of India time to time as applicable) will be made from the contractor's bill as per rule enforce.
21. In the event of contractor committing a breach on any of the terms & condition laid down in the contract at any time for performance in his duties, the CSPTCL may forfeit security deposit and terminate the agreement by giving notice in writing on this behalf. Any dispute arising out of this contract the CE (S/s-O&M) CSPTCL, Raipur's decision in the matter shall be final and binding on contractor.
22. **AGREEMENT:-** Immediately after award of contract the contractor shall have to execute an agreement on non- judicial stamp paper worth Rs. 300/- (Rs Three hundred) only and affix Revenue stamp worth Rs.1/- for which cost will have to be born by the contractor. The agreement will be signed in prescribed proforma of CE (S/s-O&M) CSPTCL, Raipur or his authorized representative.
23. The labour engaged by the contractor should be insured under the Workmen Compensation Act & the Employees liability shall be on contractor as per statutory provisions during the entire period of the contract including extended time, if any. The contractor has to arrange all safety appliances etc to their labours & safety rule should be followed strictly.
24. All suits or proceeding relating to any dispute of claims arising out during the course of contract or performance of the contractor should be made in the court at Raipur only.
25. The C.E.(S/s-O&M) CSPTCL Raipur reserves the rights to amend or cancel the order without assigning any reason.
