Money orders will be accepted only up to 10 days prior to the due date of opening of tender. After that money orders will not be accepted and tender documents will not be sent by post.

The tender in the prescribed Tender Form with earnest money Rs. 1000/- (Rupees one thousand only) in the form of DD payable in favor of RAO, CSPTCL, Raipur should be dropped in the tender box up to 15.00 hrs on or before 30.06.2021

In case EMD is deposited in the form of cash in the office of the undersigned, the money receipt should be submitted with tender form.

Bids will be opened on 30.06.2021 at 16:00 hrs in presence of those bidders who choose to be present. In case of holiday declared by the Government on the scheduled date, the last date for submission and opening of tender will automatically be transferred on next working day. Offers without earnest money will be rejected.
