Covers should invariably be super **Supply of Choke for 250W HPSV Lamp at various EHV S/s under EE (S/s) Dn. CSPTCL, Raigarh** and should be accompanied with Bankers Cheque or DD/payable in favor of the Sr. Accounts Officer, CSPTCL, Bilaspur payable at Bilaspur EMD for ₹ 500.00 (₹ Five Hundred) Only CSPTCL, Bilaspur (C.G.). The tender will be opened on **29/06/2021 at 15.30 Hrs**

1) Tender must be dropped in the tender box at the office of SE (S/s-O&M), Circle CSPTCL, Bilaspur by 15.00 Hrs. on **29.06.2021** Tenders received after scheduled time & date will not be considered. Tenders will be opened on the same date at 16:00 Hrs. in this office. The date of opening may extend to next working day, if the Government declares holiday.

2) **Pre.Bid Qualifying Requirements:-**

The Tenderer shall comply the following requirements and should submit document in support alongwith the commercial bid:-

- a) The bidder should be manufacturer or authorized distributor of manufacturing company or registered supplier in CSPTCL.
- b) The contractor shall have to submit self certified copy of vender Registration, GST Registration, and Pan card etc. with tender documents.

The above documentary evidence shall have to submit alongwith tender document (technical & commercial bids) in mandatory.

- 3) When tenders are delivered by special messenger, it should be dropped in the tender box kept in the office of the SE (S/s- O&M), Circle CSPTCL, Bilaspur on working day between 10.30 Hrs. to 17.30 Hrs.. However, on the submission date, tender can be dropped only up to 15.00 Hrs. Any kind of receipt towards submission of tender documents by the firm shall not be issued by this office.
- 4) The SE (S/s- O&M) Circle CSPTCL, Bilaspur on behalf of the CSPTCL reserves the right to reject any or all bids or to accept any bid considered advantageous to the CSPTCL, whether it is lowest or not and the same shall be binding on the bidders.

- 16) **PRICE :-**The prices should be quoted F.O.R. Destination at Bilaspur including packing, forwarding, freight, insurance, GST and any other charges.
- 17) **PERFORMANCE GUARANTEE / DEFECTIVE SUPPLIES :-**If during the course of 12 months from the date of supply of materials in Area Stores, any of the goods is found to be defective in materials or workmanship or develop defect in service, the same will be rectified by you free of all charges.
