

Those bidders who desire to obtain the tender documents by Registered Post, postal charges Rs 200/- (Rs Two hundred only) should also be sent in advance by DD along with cost of Tender document Rs. 300/- + GST@12%.

The bidders must be registered in CSPCL with proper validity period as per the company's rules. The Firm's registration No. and its validity for local purchase material with CSPCL must be mentioned on the top of envelop (offer) failing which the offer shall not be considered for further processing of Tender/Bid.
