Covers should invariably be super **250W HPSV Lamp, Ignitor and Capacitor for 132 KV S/s Sheorinarayan and 132 KV S/s Mungeli under EE (S/s) Dn. CSPTCL, Bilaspur** and should be accompanied with Bankers Cheque or DD/payable in favor of the RAO, CSPTCL, Bilaspur payable at Bilaspur EMD for ₹ 500.00 (₹ Five Hundred) Only CSPTCL, Bilaspur (C.G.). 2) **Pre.Bid Qualifying Requirements:-**
