01. Tender documents, tender form/terms and conditions etc. can be purchased on payment of ₹ 236.00 (₹ Two hundred Thirty Six) only including GST@18% only in the shape of DD (Non refundable) in favour of RAO CSPTCL Bilaspur from the office of the SE (S/S-O&M), CSPTCL Bilaspur on or before 26/11/2021 up to 17.30 Hrs.
02. Tender forms along with relevant documents shall be issued to all prospective bidders who deposit appropriate tender fee. The eligibility criteria, etc shall be verified at the time of evaluation of tenders. **The bids of those bidders who qualify the criteria of opening the bids, shall be opened only and the bids of disqualify bidders shall not be opened.**
03. The contractor shall have to submit the amount of required earnest money for ₹ 1,000.00 (₹. One Thousand ) only in the shape of DD in favour of RAO CSPTCL Bilaspur against instant tender. No offer will be accepted only. The offer without EMD shall not be consider and will be rejected.
04. The sealed tender are to be on three parts basis,
  - (a) 1<sup>st</sup> envelope containing the EMD clearly super- scribed "EMD" on top,
  - (b) 2<sup>nd</sup> envelope contain Technical and Commercial Bid should the tender documents clearly super- scribed "Technical and Commercial Bid" on top and
  - (c) 3<sup>rd</sup> envelope should contain the price bid clearly super- scribed "PRICE –BID" on top.

06. The rate for Oil Leakage arresting and painting of 40MVA X-mer-I at 132 KV S/s Pathariya under EE (S/s) Dn. CSPTCL, Bilaspur with one coat of Red oxide and two coat of aluminum paint with material under E.E (S/S) Dn. CSPTCL Bilaspur. to be

quoted as per details given in offer form (Price Bid Schedule) and if there is any overwriting/cutting that should be attested with seal and signature by the contractor, otherwise the same offer will be rejected which may be noted.

07. The rates should be quoted inclusive of all charges excluding GST. The rates of GST shall have to mention on percent basis separately as per price bid.
08. The contractor shall have to submit self-certified copies of 'A' class valid Electrical License, E.P.F. Registration, labour license and Registration in B&C& GST with tender documents.
09. The lowest bidder shall have to submit the permission for execution of the work from Chief Electrical Inspector C.G. ANUGYAPAN Mandal/ state level license Board/Authority after placing of order and before taking over the site in concern division under intimation to this office
10. The contractor will have to execute an agreement on non-judicial stamp paper worth ₹300/- (₹ Three Hundred) only dully affixed ₹. 1.00 (₹ One) only of revenue stamp for which cost will be born by the contractor.
11. The agreement should be executed within 7 days (Seven days) after receipt of work order.
12. The contractor will have to deposit 10% of total value of the services portion to contract award as security deposit. The SD will have to be deposited in the shape of DD/Bankers cheque/ FDR in favour of Sr. Accounts Officer, CSPTCL, Bilaspur in this office before taking over the site. The S.D. may be deducted from contractor's bill. The SD will be released after completion of guarantee period and on payment of GST against the work order.
13. The contractor should be registered at least under category "C" for EHT & other tower line and construction work as well as EHT S/S works.
14. The site will be handed over within 7 days after execution of agreement.
15. The work included in this tender will have to completed within 60 (Sixty) days after handing over of the site. The Completion period shall be counted from the last handing over of site.
16. The contractor shall have to apply the I.S.I Marka. Asian Paints, Burger , Nerolac, etc and Red Oxide only at is on cost.
17. Before starting the painting work, the contractor bill arrange cleaning of all the steel structures either with wire/brush or similar other means etc.
18. Firstly, single coat of red oxide paint and thereafter double coat of aluminum paint has to be applied after complete dryness of red oxide paint. The workman should be of the best quality.
19. As the painting work is to be carried out on 40MVA X-mer-I at 132 KV S/s Pathariya in live sub-station switchyard, therefore, the contractor will be fully responsible for observing all necessary safety precautions/rules and maintaining the required clearance from live parts of lines & equipments. Whereas clearance are less or inadequate, the painting works are to be carried out after availing shutdown in consultation with the in charge Engineer only. Further , the painting work is to be carried out under the direct supervision of authorized person of CSPTCL only
20. The contractor should depute his labour for carrying out the painting works under supervision of his one of the experienced person who is conversant with such works in

a live EHV Sub-station only. However, the Engineer in charge will depute one of his authorized person for supervision of painting works in the 132KV S/s Pathariya.

21. The contractor shall have to registered his all the workman engaged for execution of this work under B&C establishment in the O/o Labour Commissioner of the area where work is to be started and copy of the same should be submitted to the concern Division or as per laws & rules of B&C.
22. The labour engaged by the contractor should be insured under the workmen compensation act 1923 and amended time to time by the contractor during the entire period of contract. The contractors have to be registered under EPF.
23. The payment of wages & fringe benefits should be done as per clause 22 of Nyuntamvetanadhiniyam 1948 & Labour contract act's Clause 21 of Regulation-Abolition act 1970, and also declared by Govt./Dist. Collector as enforce during the execution of work.
24. The contractor will be solely responsible for payment of work contract taxes, if any applicable enforce for which CSPTCL shall not entertain any claim in this regard. Beside this if any other taxes or duties become payable during completion period of contract, the same shall have also to be paid extra as per rules by the contractor.
25. Deduction towards income tax @ 2% as per applicable will be made from the contractor's bill as per rule enforce and hire charges for issuing T&P etc. on the basis @ 2% per month or part there of the cost of materials/T&P including store incidental charges.
26. The work shall be carried out on the full risk and cost of contractor and CSPTC.L. will not be responsible for any kind of risk coverage arising due to execution of work.
27. As this work is to be carried out in the protected area, it should be ensured that there is no damage to any of the erected equipment/appliances etc.
28. The work will be carried out by during restricted shutdown period by observing all the rules and regulations regarding safety from any type of accident which if take place, would be the contractor's responsibility. The contractor shall be responsible for payment of all compensation as applicable from time to time to their workmen engaged on the work in the event of any accident.
29. The work done by the contractor as per the contract specification should be guaranteed for a period of 12 months from the date on which work completed and measurement recorded/taken by work in-charge. If any defect noticed, during this period, should be rectified by the contractor on free of cost to CSPTCL upon written notice, provided such defects are due to bad workmanship.
30. The payment will be done by 1<sup>st</sup> & final bill through the RAO, CSPTCL, Bilaspur as per their financial limit within reasonable time from the receipt of bill through RTGS.
31. The work in charge will be Executive Engineer, (Sub-Station.) Dn. CSPTCL, Bilaspur under whom supervision or in his authorized representative; the work will have to be completed.
32. The quantum of work is tentative and depending upon the site condition. However, the work will be confirmed as soon as the work executed. The quantity of work may be increase up to 50% of total contract. The payment will be done as per actual execution of work and measurement recorded in MB by the work in charge.
33. If the contractor fails to start the work; or to complete the work as specified in the scope of work order, the undersigned reserve the right to get the unfinished work completed through some other agency on contractor's risk & cost.

34. In case of delay in execution of the work penalty @ 0.5% per week or part thereof subject to max. 10% of the total value of the order will be imposed for the balance work to be completed.
35. In the event of contractor's committing a breach on any of the terms and conditions laid down in the contract at time for performance in their duties, the Company may forfeit security deposit and terminate the agreement by giving notice in writing in this behalf. Any dispute arising out of this contract is to be referred to the SE, (S/s-O&M), Circle, Bilaspur whose decision in the matter shall be final and binding on contract.
36. As per the statutory obligation under PF Act as amended recently, the contractor will have to furnish full particulars of the engaged man power for this work. All such details will have to be furnished along with bill without which the bill will not be accepted.
