Note:

1. Refilling of Fire Extinguisher shall strictly comply directions given vide IS-2190:2010 Annex-E, clause 12.2.1 & 12.2.2.
2. Refilled of Fire Extinguisher shall cover a guarantee period up to the next refilling schedule as described vide IS-2190 Annex-D, clause 11.4.1 & 12.3.
3. Test Certificate / performance guarantee is to be submitted at the time of supply of material.
4. Safety drill is to be arranged at each S/Stns by the bidder. Drills are to be carried out with the fire extinguisher to be handed over to the bidder for refilling.
5. Minimum experience of 3 years is desired for the above work in any power company/PGCL/NTPC/BSP order copy to be enclosed.

GENERAL:

Tender documents can be obtained from the office of the undersigned on payment of Rs. 200/- + Rs. 24/- (GST @ 12%) in cash on or before **13.07.2020** up to 17.00 hrs. The application for purchase of Tender Documents should be submitted in **Letter head of the company** bearing details of :- **Firm's name, Vendor no (in Chhattisgarh State Power Companies Ltd) if any, address, Phone no, GSTIN no.** and should be duly signed by Proprietor/Authorized representative.

Postal charges worth Rs. 100/- (Rs. Hundred) should also be sent in advance by Money Order by those bidders who desire to obtain tender document by post. Money orders will be accepted only up to 10 days prior to the due date of opening of tender. After that money orders will not be accepted and tender documents will not be sent by post.

The tender in the prescribed Tender Form with earnest money **Rs. 500/- (Rupees Five Hundred only)** in the form of DD payable in favor of RAO, CSPTCL, Raipur should be dropped in the tender box up to 15.00 hrs on or before **14.07.2020**.

In case EMD is deposited in the form of cash in the office of the undersigned, the money receipt should be submitted with tender form.

Bids will be opened on **14.07.2020** at 16:00 hrs in presence of those bidders who choose to be present. In case of holiday declared by the Government on the scheduled date, the last date for submission and opening of tender will automatically be transferred on next working day. Offers without earnest money will be rejected.

Details of Money Receipt of deposit of Earnest Money should be mentioned in the top corner of tender envelop.
