**The submission of a quotation by a bidder implies that all the instructions, terms and condition etc. have been read and the bidder is aware of and has accepted these conditions.**

**01. PQR:-**

- (i) The bidder should be registered in CSPTCL.

**02.** Sealed tenders/quotations are invited by the office of SE (S/s : O&M) Circle, CSPTCL, Bilaspur for installation & supply of 01 Nos. Split Air conditioner Capacity 2.0 Ton, 3 star, along with all accessories, Model - LG/Voltas/ Mitsubishi/Samsung or equivalent make for SE (S/s : O&M) Circle, CSPTCL, Bilaspur as per the specifications. Tender must reach the office of SE (S/s:O&M) Circle, CSPTCL, Bilaspur by 14.07.2020, 15:00 Hrs. Tenders received after the stipulated time/date will not be considered. Covers should invariably be super scribed. Along with Earnest Money Deposit Rs. 1000/- (Rs. One Thousand only) by DD payable in favour of the R.A.O. CSPTCL, Bilaspur. - 09.** All the bidders shall essentially indicate the break up of price as shown in the tender form. In case any of the charges are not included in the quoted price, the same shall be clearly shown as “Extra” indicating specifically the rate/scale of such charges.

- 11. Earnest Money:-** Each bidders should submit an earnest money deposit of Rs. 1000/- (Rs. One Thousand only) prior to submission of quotation in a separate envelope. The tenders not accompanied with earnest money will summarily be rejected.
