05. VALIDITY:-Full descriptive particulars and complete specification should accompany the tender. Offers should be kept open for acceptance for at least three months(90 days) from the date of opening. However, due to circumstances beyond control, the bidders will be asked to extend validity but they shall not be permitted to revise their rates, offer any rebate or concession while extending the validity which may materially result in any reduction/increase in the computed price of their original offer.

06. The bidders would abide by the terms and conditions and specification as given in tender document and in the attached schedule & no condition or stipulation contrary to our condition shall be applicable.

07. The Trans Company reserves the right:-

- (i) To cancel any or all filled tenders or to accept any filled tender considered advantageous to the Trans Co. whether it is lowest tender or not.
- (ii) To split/increase/decrease the quantities of material/works against the tender .No reason will be assigned by the Trans Co. for these and will be binding on the bidders.

08. In case of correction done in the tender, the bidders should initial the same otherwise the tenders may not be considered.

09. Telegraphic offers will not be considered.

10. All the bidders shall essentially indicate the break up of prices as shown in the tender form. In case any of the charges are not included in the quoted price, the same shall be clearly shown as "Extra" indicating specifically the rate/scale of such charges.

11. Please note that the bidders who did not accept terms and conditions stipulated in this tender specification their offers are liable to be outrightly rejected without assigning any reason whatsoever.

12. **Earnest Money** :-Each bidders should submit an earnest money deposit of Rs.3000 /- (Rupees Three Thousand only) prior to submission of quotation in a separate envelope. The tenders not accompanied with earnest money will summarily be rejected.

13. **FORM OF EARNEST MONEY DEPOSIT**:-The earnest money deposit can be furnished in the following form,.

14. **FORFEITURE OF EARNEST MONEY DEPOSIT** :-

It should be clearly understood that in the event of bidders failing to accept and execute the telegraphic and detailed orders, if it is placed within the validity period of the offer, the full amount of earnest money will be forfeited and Trans Company decision in this respect will be final and binding on the bidders.

15. The requirements may vary as per the site conditions. The Contractor has to complete the work accordingly. The payment shall be made as per the actual work done on prorata basis. The Contractor shall be allowed to work subject to availability of consent of the OIC. If consent could not be arranged due to unfavourable system conditions, the job completion period shall be amended accordingly.

16. The rates for job are to be quoted inclusive of cost of materials, supply etc of which is in the scope of firm.

17. **PRICE** :-The prices quoted should be FIRM along with clear bifurcation of all taxes and duties.

18. **PERFORMANCE GUARANTEE / DEFECTIVE SUPPLIES** :-If during the course of 12 months from the date of completion of work, any defect is observed in workmanship/material supply, or develops defect in service, the same will be replaced by the Contractor on free of all charges.

19. **SECURITY DEPOSIT** :-The Contractor will have to deposit 10% amount of the total contract value as SD. SD may be deducted from contractor bills if the contractor requests for the same. No interest shall be paid by CSPTCL on security deposit. In case of non-fulfilment of contractual obligations by the contractor, the security deposit shall be forfeited, SD can be deposited in the form of DD/FDR in favour of (RAO) CSPTCL,Raipur.

20. **WORK COMPLETION PERIOD** :- The work shall be completed within 30 days from the date of handing over of the site.

21. **PAYMENT**: - 100% payment shall be made within 30 days after completion of work & issue of satisfactory work completion certificate by EE(C&TM)Dn.Bhilai within a month. No interest shall be payable in case of delay in payment.

22. **INCOME TAX DEDUCTION**: - Deduction towards income tax will be made from the contractor bill as per rules in force.

23. **PENALTY**: - If the contractor fails to complete the order work within the specified time schedule, the penalty will be levied @ 0.5% per week or part thereof upto a maximum of 10% on the value of un completed portion of the work ordered on the contractor.

24. **INCREASE/DECREASE IN QUANTITY**: - The Trans Co. reserves the right to increase/decrease the quantity of works upto 50%.

25. **OFFICER INCHARGE**: - The Executive Engineer (Commn. & Tele.) Dn. CSPTCL Bilaspur & KORBA for their respective substations /Or his/her authorized representative.

26. **GST & TAXES**: - The firm/bidders should clearly indicate the applicable rate of GST with HSN Code. and any other taxes in force.

27. If any accident occurs during the course of working full liabilities lies on the Contractor and no compensation will be admissible by the Trans Co. The work is to be done in the supervision of the representative of the respective substation incharge of Trans Co. only.

28. Any damage or losses occurs to the trans Co. property during the work shall be recovered from the contractor bill.

29. **DISPUTE:** -Any dispute arising out of contract shall be subject to the jurisdiction of court at Durg.

30. **AGREEMENT:** - The contractor will have to execute an agreement on non-judicial stamp paper worth Rs 250/- (Rs Two Hundred fifty) only for which cost will have to be borne by the contractor. The agreement should be executed within 15 days from date of issue of work order.

1. *The submission of a quotation by a bidder implies that all the instruction, terms and condition etc. have been read and the bidder is aware of and has accepted these conditions.*
2. The tender shall be submitted in 3 parts.
 - a. First envelope shall contain DD in favour of RAO, CSPTCL, Raipur payable at Raipur if deposited in cash, the photo copy of M.R. of Rs. 560/- (Tender No., Due date & EMD should clearly be written on this envelop) should be enclosed in this envelope.
 - b. Second envelope shall contain the page No. 1, 3, 4, 5 & 6 duly accepting the terms. (Tender No., due date should be cleared written on this envelop.) Proforma for terms & conditions & other details shall be enclosed in this envelop.
 - c. Third envelope will contain the page No. 2 i.e. the price Bid. (Tender No. Due date & Price bid should be clearly written on this envelop). All the three envelops shall be enclosed in big sealed envelope Superscripting the tender No. & due date.

Commercial Terms & Conditions

1. **Nodal officer/OIC:** The E.E. Communication & Telemetry Division Korba/bilaspur shall be the OIC of the work under their respective jurisdiction.
2. The earnest Money will be forfeited, if the bidder refuses to accept/execute the order awarded either in part or in full to complete the assigned contract work on the terms & conditions specified in order & the order will be cancelled.
3. **Payment :** The bills shall be submitted in triplicate to OIC after successful completion work. The payment shall be released by the RAO, CSPTCL, Raipur within reasonable time which is normally within 30 days. No interest shall be paid in case of delay in payment.
4. Deduction towards income tax & labour can if applicable will be made from the bidder's bill as per the rules in force.
5. **Security Deposit:-**In case, bid is accepted & order is placed, 10% of value of order shall be submitted by firm as security deposit in the form of DD/FDR payable to RAO, CSPTCL, Raipur within 30 days from the date of order. Security Deposit will be refundable/released after guarantee period plus claim period of 03 month. SD may be deducted from bills if the bidder requests for the same.
6. **Taxes:-**Bifurcation of applicable taxes (on composite job/work/providing & installation of material) should be clearly mentioned in the bid. The taxes will be applicable as per prevailing rate for contract period. It may be noted that only statutory variations due to Govt. Regulation in the rate of GST if any shall be payable by CSPTCL, Only within contractual period. In case the contractor is affected late i.e. beyond contractual completion period & rates of GST under goes upward revision the payment will continue to be made only on the basis of rates prevailing during the contractual period. However in case the rate of statutory levies under goes downward revision than the delayed work completion beyond contractual period will attract reduced rate of levies.
7. **Delivery period:-**The delivery of 36/40W LED panel light should be completed within 30 days from the date of order.
8. If the bidder fails to complete the specified supply, the remaining supply shall be got done through other agency and the payment made to them shall be recovered from bidder's shall or money of contractor deposited with CSPTCL, in any form.
9. **Guarantee: -**The supplied 36/40W LED Panel Light shall be guaranteed for 12 months from the date of supply.
10. **Penalty:-**Penalty of ½ per week of the total contract value subject to maximum 10% will be levied if the supply of material is not done in the specification time.
11. **Cancellation of order:-**The CSPTCL may upon written notice of default, terminate contact in the circumstances detailed here under.
 - (a) If in the opinion the CSPTCL, the contractor fails to deliver/complete the materials/job work within the time specified or during the period for which extension has been granted by the CSPTCL.
 - (b) If in the opinion of the CSPTCL, the Contractor fails to comply with any of the provisions of the contract.
