### Terms & Conditions

1. **The submission of a tender by a bidder implies that all the instructions, terms and conditions etc. have been read and the bidder is aware of and has accepted these terms and conditions.**
2. The tender shall be submitted in 3 parts.
  - a. **First envelop** shall contain DD in favour of Regional Accounts Officer, CSPTCL, Bilaspur payable at Bilaspur if deposited in cash, the photo copy of M.R. of Rs. 500/-. (Tender No., Due date & EMD should clearly be written on this envelop)
  - b. **Second envelop** shall contain the all the pages except price Bid the terms. (Tender No., Due date should be clearly written on this envelop.)
  - c. **Third envelop** will contain only the Price Bid. (Tender No., Due date & Price Bid should be clearly written on this envelop). All the three envelops shall be enclosed in big sealed envelope superscripting the tender No. & due date.
3. Tender must be dropped in the tender box at the office of SE (S/s-O&M), Circle CSPTCL, Bilaspur by 15.00 Hrs. on **26.09.2020** Tenders received after scheduled time & date will not be considered. Tenders will be opened on the same date at 15.30 Hrs. in this office. The date of opening may extend to next working day, if the Government declares holiday.
4. When tenders are delivered by special messenger, it should be dropped in the tender box kept in the office of the SE (S/s- O&M), Circle CSPTCL, Bilaspur on working day between 10.30 Hrs. to 17.30 Hrs.. However, on the submission date, tender can be dropped only up to 15.00 Hrs. Any kind of receipt towards submission of tender documents by the firm shall not be issued by this office
5. The SE (S/s- O&M) Circle CSPTCL, Bilaspur on behalf of the CSPTCL reserves the right to reject any or all bids or to accept any bid considered advantageous to the CSPTCL, whether it is lowest or not and the same shall be binding on the bidders.
6. Telegraphic/Fax offer shall not be accepted.
7. The rate to be quoted as per details given on front page and if there is any overwriting/cutting that should be initialed with seal and signature by the contractor, otherwise the same offer will be rejected which may be noted.
8. Deduction toward Income Tax as per applicable will be made from the contractor's bill as per rule in force on the basis of 2% per month or part thereof to the cost of material/T&P including store incidental charges.
9. The Contractor will have to settle all the related problems himself although the possible assistance will be given by CSPTCL
10. The Security deposit shall be refunded to the contractor after "No Dues certificate" is given by the concerned EE after supply of materials.
11. The transfer of tender forms purchased by the tenderes to another is not permissible.
12. **Validity:** The offer should be valid for 90 days from the date of opening of bids.
13. The bidder who is willing to carry out the above work should furnish the Earnest Money of Rs. 500/- (Rupees Five Hundred) only along with the tender form (in a separate envelop) through Money Receipt/DD in favour of the Regional Account Officer, CSPTCL, Bilaspur payable at Bilaspur, along with his bid. If the Earnest Money is not deposited, tender form will be rejected.
14. The earnest Money will be forfeited, if the bidder refuses to accept/execute the order awarded either in part or in full to complete the assigned contract work on the terms & conditions specified in order & the order will be cancelled.
15. EMD of unsuccessful bidders will be refunded after tender is decided/order is placed to L1 bidder. In case the tender is dropped by CSPTCL after opening of price bids for reasons whatsoever the EMD of participant bidders will be refunded within reasonable time. The EMD of successful bidder (L1) will be refunded after receipt of Security Deposit against the order placed.
16. **SECURITY DEPOSIT :-** An amount equal to 10% of the entire value of the contract will have to be deposited by the successful bidder as Security Deposit, which will be released only after successfully completion of the guarantee period without any interest.

17. **GUARANTEE:** - The material should cover a guarantee for a period of 12 months against manufacturing defects. The supplied materials should be genuine. If the materials are found duplicate or Sub-standard, the firm will be black listed & recovery will be made from the supplier in this regard.
18. **PAYMENT:-** 100% Payment will be made by the Regional Accounts Officer, CSPTCL, Bilaspur within 30 days from the date of receipt of materials in good condition and submission of supplier's bill in triplicate to the consignee. No interest will be paid in case of delay in payment.
19. **PENALTY:-** If supplier/ tenderer fails to supply the material within the specified time/ schedule, the penalty will be levied @ 0.5% per week or part thereof subject to a maximum of 10% on the value of unsupplied material.
20. **INCREASE/DECREASE IN QUANTITY:-** The CSPTCL reserves the right to increase/decrease the quantity up to 50%.
