Tenders received after the stipulated time/date will not be considered. - **VALIDITY:-**Full descriptive particulars and complete specification should accompany the tender. Offers should be kept open for acceptance for at least three months(90 days) from the date of opening. However, due to circumstances beyond control, the bidders will be allowed to extend validity but they shall not be permitted to revise their rates, offer any rebate or concession while extending the validity which may materially result in any reduction/increase in the computed price of their original offer.

PERFORMANCE GUARANTEE / DEFECTIVE SUPPLIES: If during the course of 12 months from the date of completion of work, any of the goods is found to be defective in materials or as per manufacturers warranty(whichever is higher), or develops defect in service, the same will be replaced by the Contractor on free of all charges.
- **SECURITY DEPOSIT**:-The Contractor will have to deposit 10% amount of the total contract value as SD. SD may be deducted from contractor bills if the contractor requests for the same.
